

DESCRIPTION OF 15.657 ACRE TRACT

Being part of Lot 644 in Northstar Section 1, Phase A (Official Record 817, Page 2747), Berkshire Township, Delaware County, State of Ohio and being more particularly described as follows;

Commencing at the southwesterly corner of Lot 644 in Northstar Section 1, Phase A (Official Record 817, Page 2747), said point being the northwesterly corner of a 24.561-acre tract of land conveyed to CFJ Properties by deed of record in Deed Volume 552, Page 257 and in the easterly right of way line of Interstate 71;

Thence along the easterly line Interstate 71 and the westerly line of Lot 644, North 03° 07' 49" East for a distance of 218.27 feet to a point;

Thence continuing along the easterly line Interstate 71 and the westerly line of Lot 644, North 02° 42' 17" East for a distance of 4.39 feet to the **True Point of Beginning**;

Thence continuing along the easterly line Interstate 71 and the westerly line of Lot 644, **North 02° 42' 17" East** for a distance of **500.00 feet** to a point;

Thence across Lot 644, South 87° 17' 44" East for a distance of 676.52 feet to a point;

Thence continuing across Lot 644, North 56° 39' 28" East for a distance of 269.95 feet to a point in the westerly line of a Future 70 ft. wide Road;

Thence along the westerly line of said Future 70 ft. wide Road and a curve to the left having a radius of 385.00 feet, a delta of 41° 53' 35", a tangent of 147.38 feet and a chord bearing **South** 55° 20' 02" East, a chord distance of 275.27 feet for an arc length of 281.50 feet to a point;

Thence continuing along the westerly line of said Future 70 ft. wide Road South 76° 16' 50" East for a distance of 120.80 feet to a point

Thence continuing along the westerly line of said Future 70 ft. wide Road and a curve to the right having a radius of 50.00 feet, a delta of 83° 29' 36", a tangent of 44.62 feet and a chord bearing **South 34° 32' 03" West**, a chord distance of **66.58 feet** for an arc length of 72.86 feet to a point in the westerly line of Wilson Road (100 feet wide) and in the easterly line of Lot 644;

Thence along the westerly line of Wilson Road and the easterly line of Lot 644, **South 03° 31'** 17" West for a distance of 405.17 feet to a point;

Thence across Lot 644, North 86° 42' 29" West for a distance of 1279.40 feet to the Point of Beginning and containing 15.657 Acres, more or less, and subject to all legal easements, agreements and rights-of-way of record.
