This report reflects the dedication and professionalism of our personnel, and it highlights the essential services we provide to the communities of Berkshire Township, the City of Sunbury, Trenton Township, and the Village of Galena—services that would not be possible without your ongoing support.

The year 2024 was marked by significant activity and continued growth across our service area. Call volume, fire inspections, and community development reached new record levels. In addition to this upward trend, we responded to unique and challenging events. In March, a tornado impacted every jurisdiction within our district. Despite widespread damage, we are grateful to report there were no injuries or fatalities—an outcome that speaks to the resilience and preparedness of our communities. Later in the year, we coordinated emergency operations for the solar eclipse, planning extensively to ensure public safety. Once again, we were fortunate that the day passed without incident.

Perhaps the most defining moment of 2024 was the successful passage of a 0.78 mill bond issue, approved by voters, to fund the construction of our second fire station—Station 352. The new station, to be located at 485 Wilson Road near Camping World, represents a crucial expansion of our operational capacity. Groundbreaking is expected in early 2025, with occupancy anticipated in the first quarter of 2026.

We want to extend our deepest gratitude to the voters for your confidence and support. Your approval of the bond issue is not just a vote for bricks and mortar—it is a powerful affirmation of your trust in our mission and your commitment to enhancing public safety. Your investment will allow us to respond more quickly and efficiently as our communities continue to grow. This new station is a reflection of your partnership with us, and we are honored to serve a public that values safety, service, and readiness. Thank you for standing with us.

As we look to the future, we remain steadfast in our commitment to meeting the challenges ahead and exceeding your expectations.

When I am called to duty God, wherever flames may rage, give me strength to save a life, whatever be its age.


Help me to embrace a little child, before it is too late, or save an older person from the horror of that fate.

Enable me to be alert, to hear the weakest shout, and quickly and efficiently to put the fire out.




# ORGANIZATIONAL CHART







#### **2024 Turnout Time Compliance**



Turnout time is measured from when the alarm at the station goes off, until we are on the truck responding. It is the only time within the 911 chain that we can control. Therefore, we take it very seriously.

NFPA recommends a turnout time of 60 seconds for EMS runs, and 80 seconds for fire runs, for 90% of responses. As you can see above, we exceed the national standard.






#### TRENDING STATISTICS


# HISTORICAL OVERLAPPING CALLS


#### HISTORICAL EMS CALLS

While BST&G does not operate a transport ambulance, all of our firefighters are trained in Emergency Medicine at least to the EMT-Basic level. We also have six trained paramedics on staff that allow us a higher level of patient care on the days they are working. The Fire District currently responds on all Advanced Life Support level EMS calls jointly with Delaware County EMS Medics 2 and 11, which are housed at DCEMS Station 2.





#### HISTORICAL FIRE CALLS

and Electrical Emergencies




#### HISTORIC POPULATION VS CALL VOLUME






