COMES NOW the undersigned, a Peace Officer as defined by the laws of the State of Nebraska, and being first duly sworn upon oath, deposes and states as follows:

**OFFENSE: ENTICEMENT BY ELECTRONIC COMMUNICATION DEVICE,  
28-833, IV FELONY**

**LOCATION OF OFFENSE: LINCOLN, LANCASTER COUNTY, NEBRASKA**

**FACTS:**

1. On May 31, 2007, while using publicly available Yahoo! Messenger (Internet chat) software, Inv. Jones was using the undercover identity of a 14-year-old female child from Lincoln, Nebraska. It was while using this software that Inv. Jones was contacted by a person using Yahoo! screen name autorain3 who claimed to be a 16-year-old male from south of Lincoln. During their chat, autorain3 sent a close-up image of an erect penis to the female child, and asked, "so do you like my pic a lot", and "are you kinda horny".

2. On November 1, 2007, Inv. Jones was again contacted by Yahoo! user autorain3. During their chat, autorain3 again asked the female child for her age. Inv. Jones replied that he was 14 years old. Autorain3 immediately asked the female child, "are you a virgin", and went on to ask the female child specific questions regarding a sexual encounter she had (i.e. "did he rub and feel

you then with your pants down”, “did he have a condom on”, “did he get close to putting his dick in you”). Additionally, autorain3 asked the female child, “is your pussy shaved or is it trimmed or full,” and asked to see pictures of her body, and asked, “do you have any nude pics.” Autorain3 again sent a close-up image of an erect penis to the female child, and asked, “would you like to play with it sometime,” “have you ever sucked on a guys dick,” and “would you like to try and put my dick in you.”

3. On May 8, 2008, Inv. Jones was again contacted by Yahoo! user autorain3. During their chat, autorain3 again asked the female child for her age. Inv. Jones replied that he had just turned 15 years old. Autorain3 asked the female child, “what size of bra do you wear,” “nice are they perky”, “do you have a pic of them”, and commented that he would love to see them, then went on to ask the female child specific questions regarding a sexual encounter she had (i.e. “did you rub his cock and suck on it”, and “did you let him kiss your pussy”).

4. Through investigation, Inv. Jones identified the probable user of Yahoo! screen name autorain3 as NATHAN J. JASA, DOB 05-20-1978.

5. On September 29, 2008, during an interview with NATHAN J. JASA, he admitted to Inv. Jones that he is the user of Yahoo! screen name autorain3, and that he participated in the chats that occurred on May 31, 2007, November 1, 2007, and May 8, 2008.


6. During the chat sessions, Inv. Jones was located in Lincoln, Lancaster County, Nebraska.

7. Through the efforts of this investigation, Affiant has probable cause to believe and does believe that on November 1, 2007, NATHAN J. JASA, DOB 05-20-1978, then therein did commit Enticement by Electronic Communication Device in violation of Nebraska State Statute 28-833, a class IV Felony; and these crimes did occur in Lincoln, Lancaster County, Nebraska.

8. On September 29, 2008, at 1010 hours, NATHAN J. JASA was arrested; JASA was transported and remanded to the custody of the Lancaster County Department of Corrections.

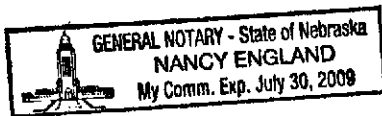
