**EAST COAST HUI SURF CAMP**

In consideration of the services of East Coast Hui, their agents, owners, officers, volunteers, participants, employees, and other persons or entities acting in any capacity on their behalf; herein and after collectively referred to as East Coast Hui; I hereby agree to release, indemnify, and discharge East Coast Hui on behalf of myself, my spouse, my children, my heirs, assigns, personal representative and estate as follows.

1. I acknowledge that surfing and other East Coast Surfing Camp Activities entail known and unanticipated risks that could result in physical or emotional injury, paralysis, death or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activities.

- The risks include, being hit by the equipment or other surfers on their boards which could result in cuts, bruises, abrasions, and concussions; hitting the bottom of the ocean; sprains; strains; broken bones; paralysis, even death; exhaustion; dehydration, sunburn; exposure to poisonous and/or carnivorous sea creatures; and accidental drowning.

- Furthermore; East Coast Hui employees have difficult jobs, to perform. They seek safety, but they are not infallible. They might be aware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used may malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in the activity. My participation in the activity is purely voluntary, and I elect to participate in spite of the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless East Coast Hui from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of East Coast Hui's equipment or facilities, including any such claims which allege negligent acts or omissions of East Coast Hui.

4. Should East Coast Hui or anyone acting on their behalf, be required to incur attorney's fee and costs to enforce this agreement, I agree to indemnify and hold them harmless from all such fees and costs.

5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medial or physical condition I may have.

6. In the event that I file a lawsuit against East Coast Hui, I agree to do so solely in the state of Massachusetts, and I further agree that the substantive law of Massachusetts shall apply in that action without regard to the conflict of law or rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against East Coast Hui and Robert C. Fenton, on the basis of any claim from which I have released them herein.
