- B. GIS Mapping Systems Ryan Hunsicker ESRI Conference was last month. Artificial Intelligence (AI) is being embedded into all parts of the program. Ryan says it is promising, but scary. He has concerns about the final product that the user is given. The program will give you an answer or solution, but you have to check to see if it is correct. California Geographic Information Association (CGIA) and URISA have no update. Also ESRI is pushing out Deed Reader software. Ryan says the program will read a legal description and will do a coordinate geometry traverse. Ryan tested the program. He says it works fine for a clean and simple metes and bounds legal description.
- C. GPS\CORS\CSRC Greg Helmer Steve Martin is new Executive Chair for CSRC. CSRC has a meeting October 16. Greg will be giving a CLSA webinar about 2025 epoch.
