# Minutes

- F. Monument Preservation David McMillan not present. Dave sent in his report by text. Committee sending out questionnaire for members to get input. Dave working on monument app and proof of concept project.
- V. Old Business: 2026 Officer Recruitment still ongoing. CEAC Record of Survey and Corner Record Guide (Guide) is in draft form. Read the draft copy and make necessary comments. Greg Helmer commented that the Guide is partially coming from this group also so we should be reading it.
- New Business: Dana Baumann, Contra Costa County, complained about seeing more non-licensed VI. people doing work in her county. She added that one of her surveyors had his license tags set out of area and not by him. Tom Dougherty, City of Fremont, asked "Does a lot and block survey automatically trigger a R/S?". Per August Hanks, Santa Clara County, yes that triggers an R/S if there is a lack of monumentation control. Good discussion was had on this topic. Joe Dechellis, Ventura County, and others, has seen Corner Records using curb splits for control. The problem is that curb split does not satisfy sufficient control per LS Act 8765. Tom Dougherty asked "When is it the cities responsibility for monument preservation?" More good discussion. Kevin Hills said Newport Beach was sued for allowing improvements in the right-of-way. Sam Ochoa, San Bernardino County, asked "Does the JPPC ever produce a white paper on cases they work on?" There was no solid answer. Joey Waltz, City of Ventura, reminded the group that Ric Moore, BPELSG, will come to your chapter meeting to talk about monument pres. It was suggested by Kevin Hills to invite Ric to speak at an upcoming LCSO meeting. August Hanks said his county requires setback letter for all Additional Dwelling Units which requires a subdivision map. The bay area counties are seeing more SB9 maps that southern California counties.
