#### Limited Warranty

1. In the event that this puppy is found to be unhealthy by the opinion of a licensed veterinarian or has any physical problems that will limit the pup's quality of life- I will replace the pup of equal value as soon as one becomes available. You must take your puppy to a vet within 72 hours from the date of possession from breeder to make this claim valid. You are not REQUIRED to take your puppy to a veterinarian; however, this exam will validate the health of your pup as warranted in this agreement. The puppy must be returned to me promptly following examination should any life-threatening issue be diagnosed- please note exclusion on #5 below. A written document from your vet is required. All warranties apply only to the original buyer. This is a limited warranty and does not warranty against ANY internal or external parasites or bacteria including giardia, coccidia or campylobacter- proper preventive measures have been given by breeder but is not guaranteed. Puppies are highly susceptible to these bacteria and parasites and have a limited natural resistance to them. A puppy's transition to a new home or travel time will greatly increase his stress level making these issues duplicate and cause symptomatic loose stool. Puppies commonly experience loose stool under stress and is not an indication in itself of a parasite/bacteria risk, however you should have your veterinarian examine any issues of concern. At no time is seller responsible for vet fees or refunds offered. X\_\_\_\_\_
2. Seller does not guarantee coat color or quality of, length, size or temperament of pup at maturity. No guarantees are made regarding ear set or conformation. If breeding rights are purchased no guarantees are made regarding quality or ability to breed X\_\_\_\_\_
3. Should your pup be veterinary diagnosed with a life-threatening issue pertaining to congenital or hereditary issues within 1 year of life a replacement pup will be given of equal value. Should death occur within 1 year of life due to suspect of congenital/hereditary issue, a necropsy report with official cause of death diagnosis must be submitted to breeder under warranty replacement agreement. The buyer understands that the breed of pup may not be the same as original purchase due to potential changes in breeder's future goals X\_\_\_\_\_
4. We do not support the practices of Banfield Veterinary chain. Any diagnosis found or advice given by Banfield will not be honored as part of this warranty. We recommend seeking a private veterinary clinic that supports responsible breeders. X\_\_\_\_\_
5. Tiny breeds can be subject to hypoglycemia, please familiarize yourself with the risks, causes and prevention of this issue. Stress of travel and new environment can add to this and is buyer's responsibility to be prepared. Buyer should also maintain proper access to food to minimize these risks.
6. A common risk of some breeds is becoming overweight at a young age. Rapid growth and inappropriate weight gain increases stress on developing joints as well as other lifelong issues if allowed to remain overweight. It is important to learn the proper amount of diet and exercise that is appropriate for the size and age of your pup X\_\_\_\_\_
7. CDPA, CDDY, IVDD are extremely common traits & diseases found in dwarf and toy breeds. This warranty does not guarantee against the presence of these genes nor any potential risks as the genes are common in the genetic makeup of their size. No warranties or guarantees are extended beyond above mentioned. Including but not limited to guarantees of fertility or undescended testicles, color dilution alopecia, cancers or any other non life threatening issues that may/may not occur. X\_\_\_\_\_

No honor in discrepancies in genetic testing results provided by any genetic testing Lab included or limited to the testing lab used on parents if any. No guarantees are made regarding testing that the parents have been tested for or other available testing that may/may not be available .X\_\_\_\_\_
9. STRONGLY RECOMMENDED!!!! DO NOT take your pup to public places and allow on the ground until all routine vaccines have been given! This is usually around 4 months of age. The breeder cannot guarantee against Parvo contamination (despite vaccines!) and is your responsibility to protect your pup. The pup is being sold with up to date shot records and internal parasite prevention. Internal & External parasite prevention MUST be continued routinely!
10. This agreement is governed by the laws in the state of Arkansas. If for any reason any part of this agreement should need legal action to enforce, that action will be initiated in the county of the Seller's residence.

### Non Breeding Rights

The following agreement is non-breed specific, details specific to a breed will be noted:
