Elections

Our Beach Parcel Committee, chaired by Allen Sayles, has been operating mostly via the subcommittees for the individual parcels. We have completed the landscape enhancements of the Silver and Oak Parcels, while the Trout subcommittee is well into the planning process for their parcel. We are looking for volunteers to participate in a subcommittee for the Fern parcel. Developments

Since our last newsletter and the amendments of the Shoreline Ordinance, we have been working with TRPA to determine the possibility have creating an exclusive HHOA pier and buoy field.

1. HHOA Pier

Six members of the board of directors and Dan Higgins met with John Marshall, TRPA General Counsel and Tiffany Good Shoreline Program Manager for an hour at TRPA on September 16, 2019 to discuss the pier application rejection and the future possibilities for HHOA buoys. After extensive discussions, and email exchanges over months following the meeting, it became clear that the HHOA pier application was turned down for reasonable causes that are outlined in the TRPA Code of Ordinances. In short, our small beach parcels cannot be developed to support facilities for an association pier, like adequate parking and rest rooms.

Although no longer relevant, the summer survey sent out last summer ("Summer Survey") showed that only 10 members who would be willing to contribute funds for the pier construction for a collective total of \$160k, which is most likely considerably less than the ultimate amount required. Based on this survey alone, it is probably safe to conclude that we would have difficulties financing a pier if we had been successful in obtaining a permit.

2. HHOA Buoys

During our TRA September meeting, it appeared that TRPA was uncertain about our ability to obtain permits for Association buoy fields under the current Code of Ordinances. Regardless, Marshall and Good recognized the importance of establishing an association buoy field and indicated a willingness to work with us to try to make that possible.

Ironically, in an email from John Marshall to us in November, he stated that the wording in the current Code would prohibit the creation of permitted buoy fields for the HHOA. However, he also stated that the Shoreline Steering Committee has unanimously recommended a code amendment to provide grandfathering opportunities for existing HOA buoy fields along the lines that are now possible for private unpermitted buoys. They anticipate bringing forward this code change in the near future.

With this uncertainty, the HHOA has put our application for buoy fields located off our beach parcels on hold. Given the ultimate goal of the Shoreline Ordinance and our meeting in September at TRPA, we are cautiously optimistic that we will eventually be able to establish HHOA buoy fields with appropriate permits.

The Summer Survey also attempted to gauge the demand of the membership to use a buoy. At that time, we estimated that the cost to HHOA buoy users would be approximately \$900/yr plus insurance. The Summer Survey indicated that 15 members were willing to support 20 buoys (5 of those 15 members were willing to support two buoys). Since placement rules would allow 7 buoys per parcel, it appears that the current demand can be met purely by placing these buoys at the end of the two most requested beach parcels, Fern and Trout Streets. The \$900 amount was based on maintenance expense, permit fees, and the amortization of the acquisition costs. We anticipate additional costs and will investigate these expenses once TRPA amends the Shoreline Ordinance.

Homewood Mountain Resort redevelopment

Art Chapman, head of JMA Ventures, gave an email report to the board that JMA is in the final stages of negotiating agreements with financial partners which will allow them to move forward with the redevelopment. As currently envisioned, the hotel portion will be put on hold, the gondola to replace the Madden Chair will be built, and there will be a phased development of the residential units, with the number of units reduced by 25% over the original approved plans. They hope to start as early as this summer.
