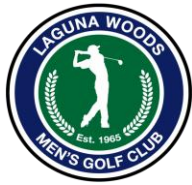
President's ball has 60 confirmed attendees as well as 12 complimentary guests. It was suggested to not provide meals for the AV guys since we were mandated to have 2 .
