Thank you for submitting Request of Exemption forms and related information. Determinations are based on Michigan laws for registering charities, the Charitable Organizations and Solicitations Act (COSA), MCL 400.271 et seq. and the Supervision of Trustees for Charitable Purposes Act (STCPA), MCL 14.251 et seq.

It appears this organization does not have 501(c)(3) charitable purposes nor will apply for this status. Therefore, registration under COSA is not required. Assets held to carry out the organization's purpose are not 501(c) (3) charitable assets. Therefore, registration under STCPA is not required.

If in the future the organization adopts a charitable purpose or receives 501(c)(3) tax exempt status from the IRS, notify our office as registration may be required. Registration with our office is separate from the requirements of the Bureau of State Lottery or other agencies.
