#### Every Student must read and understand this Waiver before participating in Martial Arts Activities.

The following Waiver of all claims, release from all liability, assumption of all risks, agreement not to sue and other terms of the agreement are entered into by me on behalf of the undersigned Student (the "Student") with and for the benefit of the *Leadership Development through Karate Foundation (LDK Foundation)*, its directors, officers, employees, volunteers, business operators, agents and site property owners or lessees.

#### Please review each item:

- 1. "Martial Arts Activities" includes but is not limited to contact and non-contact martial arts activities, lessons, classes, training, use of facilities, programs and services provided to the Student by the Organization.
- 2. I am aware that there are inherent and significant dangers, hazards and risks ("Risks") associated with the participation in "Martial Arts Activities". I am aware that the Risks include but are not limited to injury from physical contact with other students, instructors or equipment, performing a skill incorrectly, or potentially dangerous obstacles, conditions or weapons on the floor or vicinity of the Martial Arts Activities. I understand that the Risks are relative to my state of fitness or health (physical, mental and emotional), and to the awareness, care and skill with which the student conducts him or herself while participating in Martial Arts Activities.
- 3. I freely accept and fully assume all responsibility for all Risks and possibilities of personal injury, death property damage or loss resulting from my participation in Martial Arts Activities. I freely assume responsibility for my own safety.
