The following Waiver of all claims, release from all liability, assumption of all risks, agreement not to sue and other terms of the agreement are entered into by me on behalf of the undersigned Student (the "Student") with and for the benefit of the *Leadership Development through Kohai Foundation* (*LDK Foundation*), its directors, officers, employees, volunteers, business operators, agents and site property owners or lessees.

Please review each item:

- 1. I am the Parent/Guardian of the student and am executing this waiver on behalf of the student in my capacity as Parent/Guardian and with the intent that this waiver be binding on me and the Student for all purposes.
- 2. "Martial Arts Activities" includes but is not limited to contact and non-contact martial arts activities, lessons, classes, training, use of facilities, programs and services provided to the Student by the Organization.
- 3. I am aware that there are inherent and significant dangers, hazards and risks ("Risks") associated with the participation in "Martial Arts Activities". I am aware that the Risks include but are not limited to injury from physical contact with other students, instructors or equipment, performing a skill incorrectly, or potentially dangerous obstacles, conditions or weapons on the floor or vicinity of the Martial Arts Activities.
