Dyno Registration, Waiver, Terms & Exclusions of Liability, Disclaimer & Absolute Release Engine and/or Vehicle Testing and/or Vehicle Storage

1. Hemifast Performance is described hereafter as Hemifast Performance. Owner includes the owner's nominated agent, customer or corporation. Testing includes repair, tuning, fitting, development and the supply of parts and equipment.
2. Hemifast Performance accept that the owner warrants that any engine and/or vehicle, and/or parts used in engine and vehicle accepted for testing is delivered in a suitable condition for any loads, speeds or temperatures that would be imposed, or may arise, during such testing. Testing normally imposes loads exceeding manufacturers design specification. Customer is aware that the dynamometer is designed to apply similar loading to the vehicle, as it will see during operation on the road/track and is susceptible to the same risks as on the road/track.
3. All tests are performed at maximum performance and at wide-open throttle.
4. Customer knows and accepts the potential risk of testing their vehicle on the dynamometer, which includes, but is not limited to engine failure, power train failure, suspension failure and tire failure. The owner or his/her nominated agent may either view and control such testing or supply written instructions detailing any conditions or restrictions they may wish to be imposed during such testing. If no instructions are given, the owner/agent agrees, by implication and default, that Hemifast Performance will carry out any testing at the discretion of the Hemifast Performance employee.
5. Customer knows the condition of their vehicle and assures it is in acceptable condition to run on the dynamometer; Hemifast Performance does not know, nor assumes any such knowledge of the condition of the vehicle being tested. Hemifast Performance will not be responsible for any damage, no matter how so arising, which may occur during testing or fitting of the engine or vehicle, or any direct or consequential cost or costs as a result of such testing or fitting. IE: All risks are exclusively that of the owner.
6. Customer commits that all parts of the vehicle are in good condition and are capable of full power and full throttle performance during any test performed.
7. Full race suit and safety equipment is recommended when putting any vehicle on the dyno and mandatory to NHRA standards, for any race car (i.e. racing fire suit, helmet, gloves, shoes, etc.)
8. Hemifast Performance is not responsible for any damage to the vehicle or owner during or after any portion of the dynamometer testing process, inclusive of any losses in past, current or future revenue. Hemifast Performance does not carry any insurance covering any customer property, engines, vehicles or parts for any risks at all. Hemifast Performance therefore are under no duty or responsibility of any sort whatsoever and whenever in contract or in tort or otherwise for any loss including theft, burglary, damage, harm or reduction in value which happens to the customer's property however that occurs. Customer is responsible for any damage to Hemifast Performance property during or after any portions of the dynamometer testing process.
9. Everyone except the driver must remain outside of the dyno area during operation.
10. Hemifast Performance reserves the right to withhold the customer's property until payment in full has been made for work carried out and parts supplied.
11. The above terms and exclusions of liability only apply to the extent not prohibited or made void by law, but subject only to that they are sole basis on which Hemifast Performance are willing to take on the work or other responsibilities.
12. Customer will hold harmless Hemifast Performance, its employees, associates and shareholders free from all liability for any damage that may occur during the dynamometer testing process. The is a legal contract between Hemifast Performance and you, the customer; this is a legally binding document.
13. Customer agrees that the use of any recording devices (including but not limited to cameras, smartphones, and audio/video recording devices) is strictly prohibited inside any vehicles operated by Hemifast Performance.
