### **Section 3 - Health and Welfare**

The stud dog owner confirms that to the best of their knowledge the stud dog is both fertile and in good health. The stud dog owner guarantees the birth of at least 1 live puppy, or one (1) repeat breeding will be offered for the brood bitch named herein. If no puppies result from either breeding; stud services fee will be returned to bitch owner.

The stud dog owner requires a copy of the following tests before the stud service is completed:

- CERF, SHOR, OFA or the international equivalent Eye Exam found, CLEAR of any genetic abnormalities
- OFA or equivalent Exam for Hips found, GOOD or EXCELLENT
- Brucellosis test confirming a negative result within 30 days prior to the breeding

Should test results not be available at the time of the breeding a copy of the ophthalmologist's eye exam and a letter from the attending veterinarian who performed the hip x-rays stating that in their opinion they did not see any radiographic evidence of hip dysplasia will be accepted until a copy of the official results are provided. Please note the litter registration will not be signed until these copies are provided.

#### Section 5: Contractual Requirements

- The bitch identified in this Agreement will not be sold while in whelp without written notification of such a sale to all of the Stud Dog Owners prior to the breeding taking place
- Bitch owner(s) will sell or otherwise place all 'pet quality' or 'non-breeding' quality puppies resulting from this breeding on a Canadian Kennel Club non breeding Registration, and/or a personal spay/neuter contract.
- Bitch owner(s) will provide the Stud Dog Owner with the name(s) of any individual(s) purchasing a puppy resulting from this breeding; along with which puppy each person received and whether or not that puppy is show/pet quality.
- Bitch owner(s) will sell or otherwise place all 'show quality' / 'potential breeding' puppies resulting from this breeding with a written requirement that they must have a normal hip, and eye clearance prior to being bred.
- Bitch owner(s) will NOT sell or otherwise place any puppy resulting from this breeding to any type of pet shop, broker, or volume breeder, or to a research facility.
- Bitch owner(s) will do everything they can to ensure that no puppy resulting from this breeding ends up in an animal shelter/pound/rescue or the like.
- Stud dog owners reserve the right to opt out of the breeding at any time due to uncontrollable, destructive, or aggressive behavior. This will be cause to return the bitch to her Owner(s) immediately and without providing or completing this Stud Service. If stud service has been paid, it will be returned minus any expenses incurred.

- Stud dog owner reserves the right to opt out of the breeding at any time due to any originally unforeseen faults in the bitch's conformation that are looked on as a strong negative for reproduction. If stud service has been paid, it will be returned minus any expenses incurred.
- Bitch owner(s) are responsible for any veterinary expenses incurred due to unruly behaviour of the bitch; whether to the bitch or to the stud.

#### Section 6: Consideration for the Stud Service

The bitch owner will pay the stud owner the sum of ONE THOUSAND DOLLARS (\$1,000.00 CAD Dollars) prior to the stud service.

\*\*\*We guarantee that every effort will be made to obtain at least ONE natural breeding provided that the bitch will stand without undue restraint for the breeding. If a natural tie is not obtained, an artificial insemination may be necessary as well as progesterone timing and any other tests deemed appropriate to complete the breeding. The bitch owner will be responsible for all expenses related to breeding the bitch and those expenses will be paid directly to the veterinarian providing the services and diagnostics associated with the breeding. Veterinary services while the bitch is in our care will be performed by the veterinarian of our choice. The bitch owner will be notified of any such services and/or diagnostics throughout the stud service process and it will be deemed their decision to pursue the alternative methods to a natural breeding.\*\*\*
