

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.knoxshooting.com and Knox Shooting Academy, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Knox Shooting Academy, LLC include www.knoxshooting.com and KSA. The KSA website is a ecommerce site. By using the KSA website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, KSA may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase KSA's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
