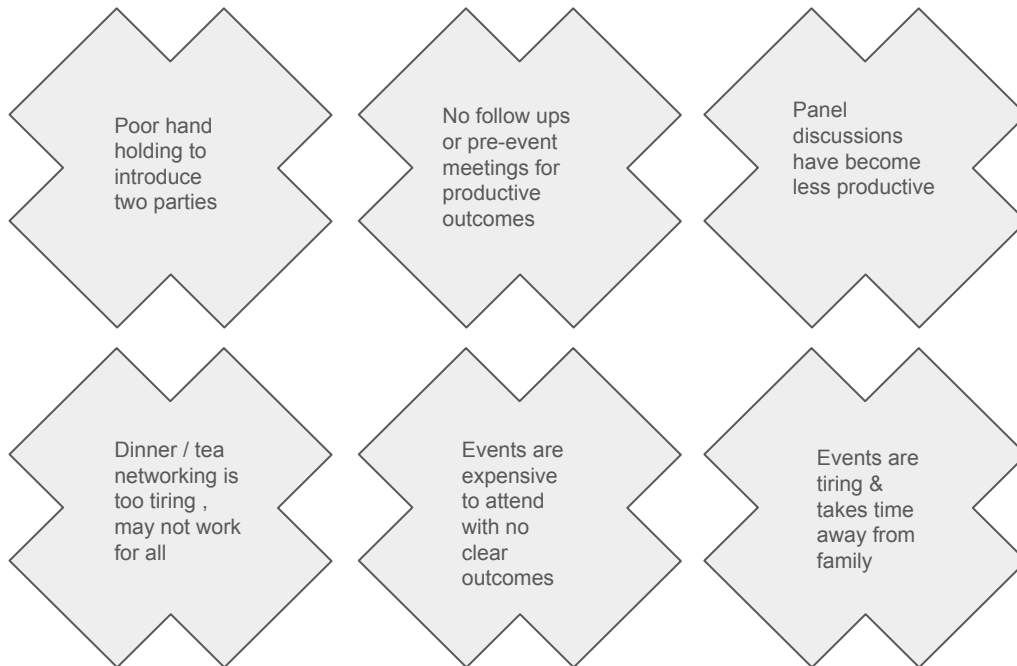

Pre-Summit Activities for Participants

- Participation registration starts on 20th Jan onwards.
- Virtual Pitch Session will be conducted on 27th March.
- Startup applications who want to pitch to investors (Startups can meet investors who are not raising currently too directly in summit)
- One of major MNC Consulting firm to review startup applications to
 - Decide which investors are relevant can be connected
 - Prepare a high level due diligence notes for investors
- Startup and investor are informed about the final plan on managed one on one meetings on 20th April
- Organiser / Consulting firms to hold online fundraise training session for startups to prepare them for finale
- Startups for record final video pitch
- Consulting team and organisers to get assessments done via Jury.
- On Demo day startups to directly interact with investors in audience for any non sensitive Q&A
- Managed One on one meetings done to arrive at decision to invest or not.
- Those investors who are convinced can issue LOIs on stop to startups for doing detailed DD and issue term sheet within 1 week from summit.





Participation Cost Contribution

Tentative pricing :

- **Free** to attend the Summit only (20th April), please arrange own stay and travel.
- **Optional** - incase attendees would like to participate in touring & stay at venue on 19th and 20th April , this might cost around Rs 12,500 per night or 2. We recommend checking in on 18th and checkout on 20th . We will refund a part of above cost incase organisers are able to close any sponsors. Team will share booking links.
