Hold Harmless and Statement of Understanding 2018

In consideration for the use of certain property at Homestead-Miami Speedway (Speedway) in the year 2018 for remote control airplane practices, races, activity and storage, the undersigned hereby forever releases, waives and discharges Homestead-Miami Speedway, LLC its parent, subsidiaries, limited liability and affiliated companies, and their respective shareholders, officers, directors, employees, members, agents, successors, assigns and the city of Homestead (collectively the HMS Indemnified Parties) harmless from any and all liability in connection with said participation for any and all loss or damage and any claim or demand on account of injury, death or loss of any kind, whether caused by the negligence of the HMS indemnified Parties.

The undersigned shall indemnify, defend and hold harmless the HMS indemnified Parties from and against any and all liability, loss damage, reasonable expenses, court costs and reasonable attorney's fees in connection with, arising out of or directly or indirectly, related to (i) any claim or loss or damage to property or of death or injury to person resulting from the undersigned's property, (ii) any claim of damage resulting from the acts of omissions of the undersigned, or (iii) any claim of damage resulting from the undersigned's breach of this agreement.

I understand that the recreational Vehicle camping is for a parking space only, it has no water, sewer or electrical hookup. My Recreational Vehicle must be totally self-contained.

I understand and agree that no sewage dumping including "gray/black water" will be permitted. Pumping services will not be available

Further, I understand that if I violate this policy I may be cited by DERM and liable for damages and clean-up of any sewage dumping, including "gray/black water". The penalties for any discharges are \$500.00 per violation per day.
