Treasurer's Report: Note - Line item for interest income is lower than expected as dividend figure had been mistakenly reinvested. Line of credit at Sturdy has been renewed. Motion by D. Hammond, seconded by J. Shaw, to approve Treasurer's Report of "Profit & Loss Budget Performance for August 2021." *Approved pending audit.*

Rector's Report: Fall program schedule has resumed. Advent to celebrate a Baptism today and one next month as well.

Wardens' Reports:

Senior Warden -

- Mulching of property scheduled
- Communion Kits Fr. Alan seeking to contact parishioners in need of visitation

Junior Warden -

New Business:
