Since we were able to have a February meeting, just a little late, I do want to share a few comments from that meeting.

- We continue to be on or under budget for expenditures to this date; working to keep up with the maintenance of all parks.
- As I mentioned in the previous newsletter the board has been working to formulate a plan for a new pool complex to be constructed at the Pavilion Park. At the meeting, we were able to finalize the proposed conceptual plans and those are attached for you to review; get an idea of what is coming. We are open to any comments or suggestion but will be moving forward quickly to complete a final set of construction drawings, set the budget and get the project underway. May not quite be ready for the summer of 24 but we are trying. It will be affordable and within a set budget.
- One last thing to mention is that the board has discussed and voted to increase the
 dues this year in anticipation of future maintenance costs for both pools. Last time we
 had an increase was in 2020 so it is not something we casually do. Our original pool
 will continue to be open providing access as always. Our thought is with the continued
 drought and expected low water levels at the river park we need to pivot and invest in
 the pools and pray for rain.

Thanks for taking a few minutes to read this and we will continue to do our best to represent the community and make wise decisions and investments.
