Hi neighbors!


I would like to take a few minutes to update you since our last newsletter.

- We continue to be on or under budget for expenditures to this date; adjusting any cost increases by redirecting funds available from other budgetary items.
- The board continues to work on the plan for a new pool at the Pavilion Park; making sure to
 cover all costs and items needed and determining the budget to undertake this endeavor. It is
 still a work in progress and will not move forward until all planning and costs are finalized and
 within an acceptable budget.
- I do want to mention that we have had feedback as to the RPOA dues increase that was approved and its connection to any new pool costs. Since our last increase, we have been diligent to cover any yearly increase in outside services provided by redistributing budgeted funds from one item to the next and staying within the set budget for the year. PARK UPDATES: IMPORTANT!!!

Please review and read all the Park Rules. You can review and print them from the website at rivermontsbtx.com. There have already been several vehicles on the River Bank. Please review #4 of the Private Park Rules & Regulations which states:

There will be no off road vehicles allowed within the park boundaries. <u>Licensed vehicles must be kept on the paved roads only and adjacent designated parking areas.</u>
Violators of this rule will be subject to a fine in the amount up to but not to exceed \$500, plus any/all expenses incurred by RPOA to repair damages, if applicable, and/or loss of all park privileges for 6 months. Additionally, State Statue 90.002 states that the operation of a motor vehicle in or on a protected fresh water area (the bed, bottom, and banks up to the gradient boundary) is prohibited and subject to a fine of \$500 by the State of Texas, separate from any RPOA fine.

The Security Cameras Signs have been placed at all Parks. If you should see any type of vandalism or any crime at any of the Parks or in the neighborhood, please contact the Comal County Sheriff Department at 830-620-3400 or 911.
