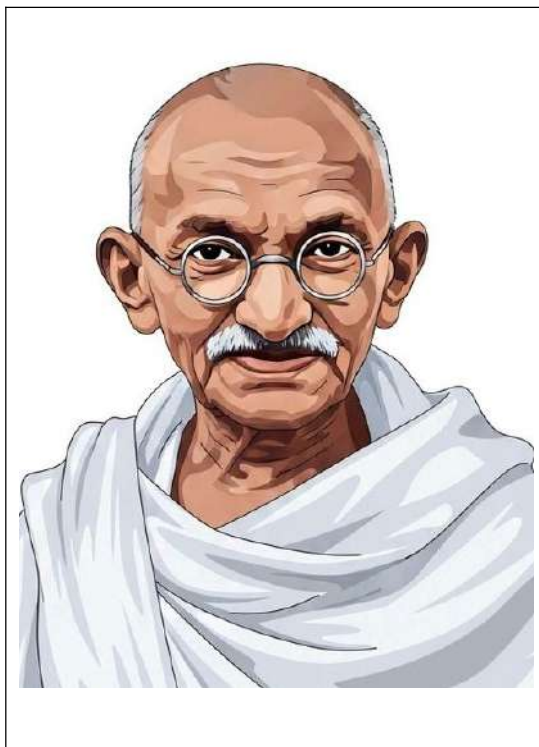

Fourth Annual Activity Report - Financial Year 2024-25:

Introduction:

ICON Charities was formally registered as an irrevocable non-profit Charitable Trust on July 7, 2021, in Kottayam, India. Guided by the vision set out in its Trust Deed, the organization is dedicated to uplifting the less fortunate, with a strong focus on supporting children's higher education. It strives to identify and extend financial assistance to deserving individuals and causes, irrespective of race, religion, caste, or gender.

Built on the strength of networking among like-minded well-wishers, ICON Charities functions as a community-driven initiative powered entirely by volunteers. Without paid staff or a formal office, it channels the compassion and generosity of its members to address pressing needs—primarily in Kerala—through educational support, basic shelter, and emergency aid during crises, including natural calamities.

The organization's partners include trustees, volunteers, donors, well-wishers, and advisors, whose collective contributions of time and resources bring its projects to life. ICON Charities serves as a platform where empathy and goodwill are transformed into meaningful impact, enabling ordinary community members to embrace philanthropy. By fostering volunteerism and promoting the joy of giving, it upholds the belief that serving society is among the noblest of civic responsibilities.

Annual Activity Report - 2024-25:

The Annual Report of **ICON Charities** covering the **fourth-year** activities for the period from April 2024 to March 2025, is presented herewith, acknowledging the loving grace of Almighty God.

1. Programs and Projects:

In line with the prime objectives of the Trust, three projects were identified and execution ongoing during the last four years.

1.1 (a) ICON Educational Excellence Awards/Scholarships

Education is the best tool available to break the cycle of poverty and hopelessness.

ICON Excellence Award (IEA) is an educational assistance program for smart students from financially disadvantaged families to come out of the grips of generations of poverty and destitution by providing partial financial assistance for their education and guidance regarding higher education.

In line with the prime objectives of the Trust, this is the primary project for ICON Charities.

During this year, identified most deserving Seventy Six (76) smart/meritorious students from less-privileged sections of the society and recognized them with scholarships as under.

Class 11& 12 – Rs 5,000/- along with merit certificate – 28 students.

Degree – Rs 10,000/- along with merit certificate – 22 students

Professional Courses – Rs 15,000/- along with merit certificate – 16 students

BSC (Nursing) - Rs 20,000/- along with merit certificate – 08 students



Students with outstanding performance (viz. MBBS students under merit quota etc) – Rs 25,000/- along with merit certificate – 1 student.

Applications invited after dissemination of information through local news paper as well as social media etc based on pre-defined criteria.

The awards were distributed to 76 most deserving selected students in a public ceremony titled “SNEHAPOORVAM” jointly arranged by ICON Charities and Snehadeepam Charitable Trust at “Mannam Samskareeka Kendram”, Pampady on 19th January 2025.

Shri PH Kurien IAS (Rtd. – Chairman, Kerala Real Estate Regulatory Authority & Ex. Addl. Chief Secretary), Shri KR Rajan (Member, Kerala Kadashvaasa Commission), Shri. CM Mathew (Pampady Block Panchayat Member), Smt. Shirly Tharyan (Ward Member), Fr. Kuriakose Kadavumbhagam, Panchayat Ward Members and other prominent citizens blessed the occasion with their presence. Capt. Dr. P Saseendran Nair (Chairman, Snehadeepam Charitable Trust) presided over and Shri. George Abraham (Chairman, ICON Charities) presented the activities of ICON Charities. Mr. Jayachandran Nair (Secretary, Snehadeepam Charitable Trust) welcomed the guests.

Prior to the award ceremony, Mentoring Session/Motivation Class to the awardees and parents was conducted by Snr. Chartered Accountant Mrs. Asha Morley.

Regular mentoring sessions are also done for the students in respect of higher education, career guidance, emotional intelligence etc.

1.2 ICON Aishwarya Homes

This is a low-cost housing project (550-600 sq. ft) for a family who owns a piece of land but can not afford to build a home for themselves. Help is also extended to deserving cases, in respect of major repairs/renovation of dilapidated houses.

Although the beneficiary is responsible for the execution, ICON does the Project Management to ensure that the house is completed in all respects. Financial help from ICON is limited to maximum Rs 4 lacs and ICON helps to mobilise balance resources for the beneficiary to complete the project.

This is an ongoing project and key handed over for Fifth and Sixth Aishwarya Homes during the year

So far, completed two new homes (sl. 2 & 5) and undertook major repairs/renovations for three others (Sl. 3, 4 & 6), providing a decent living environment for families in need without any means.

1.3 ICON Helping Hand

This is a humanitarian assistance program for those who are afflicted with natural calamities, medical conditions and personal tragedies which are not of their own making.

Fourteen such most deserving cases were supported during the year at a cost of Rs 6.40 lacs. This also covers Rs. 50,000 each to three very deserving cases and Rs. 20,000 to another deserving case to complete the major maintenance of their dilapidated houses.

Considering the transparency maintained as well as the negligible overhead, many of our well-wishers living abroad are willing to support. They all believe that it's their maiden duty to give back to the parent society from where they received all blessings, especially in the field of education for the less privileged smart children in our vicinity. In order to fulfil their dreams effectively, there is a plan to apply for FCRA approval from Govt. of India to accept FE contributions after following all guidelines in this regard. Considering that the key functionaries of the Trust are well experienced professionals who do voluntary service for ICON Charities, many in their network are inspired/motivated to support for our projects.

5. Co-operation with other NGOs/Organizations:

Efforts are made to co-operate with other like-minded and professionally run NGOs etc to build synergy for ICON's social projects. Hon. Chairman and Hon. Secretary were authorized to take further steps in this direction by the Board of Trustees. For the "ICON Excellence Award" program, support from a local NGO, "Snehadeepam Charitable Trust" is already available for the last four years to identify and shortlist the most deserving students in this regard. Thankfully acknowledge the services rendered in this regard by SDCT.

Working relationship also established with the social service arm of CET Alumni, especially its educational project HOPE, where they support and empower students from less privileged segments of the society from 8th standard onwards. Their support is thankfully acknowledged. Empowerment sessions for the tenth grade students of local Govt. Aided School (MGM HS, Pampady) regularly.

6. Appointment of Auditor: As approved by the Board of Trustees, M/s Saju and Jose, Kottayam was appointed as the auditors of the Trust for the Financial Year 2024-25 and we thankfully acknowledge their dedicated professional services.

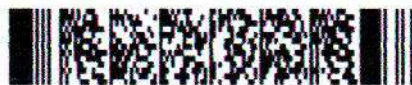
