

Annual Report 2021-22

Introduction:

ICON Charities was registered as an irrevocable non-profit Charitable Trust on 07 July 2021. Formal registration of the Trust was a dream come true for all the Trustees as well as the Well - wishers of ICON.

The preamble of the Trust Deed is reproduced below to make the primary objectives of the Trust clear:

"The objective of the non- profit organization named ICON Charities (also known as ICON) is to uplift the less fortunate in our society by empowering them with the necessary resources to succeed. It aims to identify and financially support worthy causes and deserving individuals regardless of race, religion, caste, or sex. By using the power of networking among well-wishers living across the globe, the organization will raise resources to empower and uplift deserving individuals and communities. Generous people who are empathetic to the disadvantaged will be the driving force of this humanitarian program. They will use this opportunity to help the justly identified needy persons or communities to help themselves by sharing their valuable God-given resources. The organization aims to offer meaningful and timely help at zero or negligible overhead cost".

ICON Charities is a mission driven volunteer organization whose main goal is to aid the poorest of the poor to come out of the grips of generations of poverty and destitution by providing financial assistance for their education, shelter and humanitarian needs, by making use of freely available technology, and community relationships.

The organization is managed entirely by volunteers, with no paid staff or office locations. Though the operational focus areas are dictated by the interest of ICON group members, the primary areas of operation of the organization are in supporting the needs of the poor, primarily residing in Kerala who are seeking assistance to meet the costs of education, finding basic shelter, and or other human needs arising from unexpected natural calamities etc.

ICON Charities "Partners"

ICON members, volunteers, voluntary board members, donors, and advisors are generally termed as ICON Charities "partners". The partners are those who willingly spare their resources for the projects supported by ICON Charities.

ICON Charities functions as a platform where values and aspirations of its caring and compassionate members are translated into tangible benefits for the poor and the needy in our society. It promotes simple acts of benevolence and random acts of kindness by its members and volunteers. ICON Charities enables an ordinary member of the community to become a philanthropist by providing a framework to invest one's time, talent, and money for the betterment of the community. It promotes volunteerism and demonstrates the joy of giving back to the society, as the noblest of civic duties we need to be engaged in.

Annual Report 2021-22:

The Annual Report of ICON Charities covering the first-year activities for the period from July 2021 to March 2022, is presented herewith, acknowledging the loving grace of Almighty God.

1. Programs and Projects:

In line with the prime objectives of the Trust, following projects were identified and actions initiated for execution during the year.

1.1 ICON Educational Excellence Award/Scholarship

Education is the best tool available to break the cycle of poverty and hopelessness.

ICON Excellence Award (IEA) is an educational assistance program for smart students from financially disadvantaged families to come out of the grips of generations of poverty and destitution by providing partial financial assistance for their education,

In line with the prime objectives of the Trust, this will be the primary project for ICON Charities.

During this year, identified most deserving thirty three (33) smart/meritorious students from less-privileged sections of the society and recognized them with scholarships as under:

- a) Class 11&12 Rs 5,000/- along with merit certificate 8 students.
- b) Degree Rs 10,000/- along with merit certificate 12 students
- c) Professional Courses Rs 15,000/- along with merit certificate 13students
- d) Students with outstanding performance (viz. MBBS students under merit quota etc) Rs 20,000/- along with merit certificates -Nil.

The awards were distributed to all the award winners in a public ceremony "SNEHAPOORVAM" jointly arranged by ICON and Snehadeepam Charitable Trust at "Mannam Samskareeka Kendram", Pampady on 27 th February 2022.

List of awardees for 2021-22 is attached to this report as Appendix II.

Mrs. Dally Roy, Pampady Panchayat President, Adv. G Raman Nair, Ex. Devasam Board President, Adv. Reji Zacharia, MG University Syndicate Member, Capt. Dr. P Saseendran Nair (Snehadeepam Charitable Trust President), Fr. Mathew K John, Panchayat Ward Members and other prominent citizens blessed the occasion with their presence.

Prior to the award ceremony, Mentoring Session/Motivation Class to the awardees and parents was conducted by Dr. Shanthini Thomas, Asst. Professor, CMS College, Kottayam.



Regular mentoring sessions are planned for future for these students in respect of career guidance, emotional intelligence etc.

During the ceremony, veteran teacher and author of few Malayalam books etc Mr. Kuriakose Kulathammakkal was honored with ponnada.

1.2 ICON Aishwarya Homes

This is a low-cost housing project (550-600 sq. ft) for a family who owns a piece of land but can not afford to build a home for themselves.

Although the beneficiary is responsible for the execution, ICON does the Project Management to ensure that the house is completed in all respects. Financial help from ICON is limited to Rs 4 to Rs 5 lacks and ICON helps to mobilize balance resources for the beneficiary to complete the project.

1.2.1 ICON Aishwarya Home No. 1

Mr. Purushothaman TK (82yrs) & Damp; Family, Thekkumuttil, Koottikkal PO, Kottayam (Dist.) was identified as the beneficiary for "ICON Aishwarya Home No. 1". During the landslide happened on 16 th October 2021, the family lost everything and became homeless, along with many others. ICON Volunteers visited the site and decided to join hands with Malankara Orthodox Church, who was trying to rebuild around 24 houses in that area.

With partial financing of Rs 3.9 lacs from ICON, a home for the family was managed along with a plot of land. Many well-wishers supported. In a very simple and blessed ceremony, the key for the 700 sq. ft house was handed over on 23 March 2022.

1.2.2 ICON Aishwarya Home No. 2

Mr. Anilkumar & Dist.) Parappallil (H), South Pampady P.O, Kottayam (Dist.) was identified as the beneficiary for "ICON Aishwarya Home No. 2".

During Covid situation, Anilkumar lost his private bus conductor job and the family consisting of wife and two college going children were in deep struggle. Their old leaking dilapidated house was not in living condition. ICON Volunteers visited the site and decided to join hands with other well-wishers to build a new home.

With partial financing of Rs 4.0 lacs from ICON, a home for the family is currently under advanced stage of construction and the house blessing planned before Onam 2022.

Note: House completed in all respects and blessing done on 03 September 2022.

1.3 ICON Helping Hand

This is a humanitarian assistance program for those who are afflicted with natural calamities, medical conditions and personal tragedies which are not of their own making.

Objective is to provide immediate distress relief and other assistance to eligible families, especially considering the Covid 19 pandemic.

Ten such cases were supported during the year at a cost of Rs 1,96,000/-. This also covers special educational assistance to one BSN student and marriage assistance for one deserving girl. Few cheques realized after 31.03.22 and accordingly the actual spending under this head as of 31.03.22 is less.

We are grateful to the Govt. of India for making all such registration process hassle free and efficient through their online portals.

3. National NGOs Confederation:

ICON is a registered member of National NGOs Confederation and participated in the inaugural conference and the National CSR Summit held on the 19th of May 2022 at St Teresa's College auditorium, Ernakulam. Kerala Social Welfare Minister Dr. R Bindu and other prominent personalities participated in the event.

4. Fund Raising:

- i) The initial contributions from the Founder Trustees are maintained in a Fixed Deposit as a Reserve Fund with Federal Bank.
- ii) All efforts made by all the Trustees to raise funds for the Trust for its programs. Focus is on networking with likeminded well-wishers who want to give back to the society as a thanksgiving. List of donors/sponsors for 2021-22 is attached to this report as Appendix I.

5. Way forward:

Considering the transparency maintained as well as the negligible overhead, many of our well- wishers settled aboard are willing to support. They all believe that its their maiden duty to give back to the parent society from where they received all blessings, especially in the field of education for the less privileged smart children in our vicinity. In order to fulfill their dreams effectively, we will try our best to get FCRA approval from Govt. of India to accept FE contributions after following all guidelines in this regard. Considering that the key functionaries of the Trust are well experienced professionals who does voluntary service for ICON Charities, many in their network are inspired to support for our projects.



6. Co-operation with other NGOs/Organizations:

Efforts are made to co-operate with other like-minded and professionally run NGOs etc to build synergy for ICON's social projects. Hon. Chairman and Hon. Secretary were authorized to take further steps in this direction by the Board of Trustees. For the "ICON Excellence Award" program, support from a local NGO, "Snehadeepam Charitable Trust" was sought to identify and shortlist the most deserving students in this regard. Thankfully acknowledge the services rendered in this regard by SDCT, especially its General Secretary Mr. Jayachandran Nair.

We also place on record our gratitude and appreciation for the Bishops and Priests of Malankara Orthodox Church, who also assist to identify deserving candidates for ICON

Excellence Awards and ICON Aishwarya Homes, including processing of the prescribed applications.

7. Appointment of Auditor:

As approved by the Board of Trustees, M/s Saju and Jose, Kottayam was appointed as the auditors of the Trust for the Financial Year 2021-22 and we thankfully acknowledge their dedicated professional services.

8. Thanks: We are very happy to extend our thanks and gratitude to:

- Our Bankers Federal Bank, Pampady, especially their Manager Mr. Gopikrishnan and other staff members for their dedicated support during the first year operation.

- 3. Press and visual media for the coverage of ICONs activities to create awareness in the society.


