- Over \$3,000 of gear was sold at first home game. Sales continue to be much higher after creating a separate merchandise table
- Samm Spears, baseball coach working with Anna on designing a hat for baseball to be sold through Boosters at games

OLD BUSINESS

- Winter coaches' meeting will be 10/22. Mark and Ross coordinating who will represent and what to discuss
- Guidelines for how to create a fundraiser with Boosters' TAX ID to benefit individual sports will be clarified. Michael Dietz, AD confirmed that the process should start with the athletic office and once guidelines have been established and if approved the coach/team rep can reach out to Heather.
- If sports are running their own fundraisers such as Orange & Grey it should be clarified on fundraiser announcements for transparency and the Boosters reputation in providing for sports on a balanced basis
- Additional item noted that when doing any fundraiser it should note what the goal of the fundraiser is for, equipment, travel, uniforms, ect. Boosters bylaws do have to be maintained on what the money can be spent on
