- 1. <u>Call to Order The meeting was called to order by Chairman Jerry Campeau at 5:30 p.m.</u>
- 2. <u>Roll Call of Directors</u>: Jerry Campeau, Linda Martin, Mike Nuttall and Carl Wiltbank were present. Derek Kidwell was excused. Dana Overson, Administrator, was also present. Members of the public: Jason Kirk, Wes Babers and Levi Penrod were present.
- 3. Call to Public: No Call.
- 4. <u>Approval of Minutes of Director's Regular Board Meetings June 4, 2024.</u> ACTION RE-QUIRED. **ACTION TAKEN: Mike Nuttall moved to approve the above-mentioned board minutes. Linda Martin seconded, motion carried unanimously.**
- 5. Report from Board Chair Jerry Campeau: Item a. Review of final Funding Agreements. Jerry reviewed the revisions/modifications of the 2024-2025 funding agreements. Very few changes but all reflect the awards approved June 4, 2024, during the board meeting. Jerry Campeau moved to approve the St. Johns EMS 24-25 Funding Agreement; Linda Martin seconded. Linda Martin asked Jason Kirk how many EMT's and Paramedics St. Johns EMS currently has on staff. Jason Kirk reported there is a total of 15 EMT's and 6 Paramedics: 10 FTE. There are 6 non-certified staff members, for a total of 27 in the EMS department. Motion carried unanimously. Jerry Campeau moved to approve Round Valley Fire and Medical 24-25 Funding Agreement; Linda Martin seconded; motion carried unanimously. Jerry Campeau moved to approve the Alpine Fire District 24-25 Funding Agreement; Mike Nuttall seconded; motion carried unanimously. Item b. Discussion/Approval 2024-2025 Budget/Tax Rate. Jerry Campeau reviewed the budget as approved June 4, 2024, and the Tax Rate at 0.61. **ACTION TAKEN: Jerry Campeau** moved to approve the 2024-2025 Budget and Tax Rate as presented; Mike Nuttall **seconded; motion carried unanimously.** Jerry Campeau asked that all agreements be distributed to the providers for the appropriate signatures. Once signed we will provide the executed copies to each entity.
