This includes 90 minutes of direct services: • Case history and preliminary goal setting (to be completed with a parent/guardian via phone/telehealth prior to meeting with the client) • Informal/screening assessment administration and observations. • Preliminary verbal feedback (including if a more comprehensive assessment is recommended) And 60 minutes of indirect services: • Reading of case history information and previous reports • Assessment scoring, analysis, and interpretation • Appointment-specific administrative tasks • A summary report of 2-3 pages with preliminary results and recommendations Snapdragon Speech will only charge for the time taken to complete the above services. If it takes more or less time, the speech pathologist will discuss with the client regarding this. 60 minutes of indirect time for NDIS clients is an estimate based on our previous experience.	\$484.98 (+ travel if applicable)
Initial consultations (Private paying clients)	Initial consultations for privately paying clients are typically billed at 90 minutes + travel (if applicable). This includes 60 minutes of direct services: • Case history and goal setting (to be completed with a parent/guardian via phone/telehealth prior to meeting with the client) • Informal/screening assessment administration and observations. • Preliminary verbal feedback (including if a more comprehensive assessment is recommended) And 30 minutes of indirect services: • Reading of case history information and previous reports • Assessment scoring, analysis, and interpretation • Appointment-specific administrative tasks • A summary report of 2-3 pages with preliminary results and recommendations Snapdragon Speech will only charge for the time taken to complete the above services. If it takes more or less time, the speech pathologist will discuss with the client regarding this. 30 minutes of indirect time for private paying clients is an estimate based on our previous experience.	\$300 (+ travel if applicable)

Assessment and therapy sessions for NDIS clients are typically billed at 75 minutes + travel (if applicable)

This includes 50 minutes of direct services

- The time in the session
- Discussion and feedback to parent, or if a school session, with the teacher.

And 25 minutes of indirect services:

- Planning
- Note-keeping.
- Administration
- Brief phone calls and emails to keep you updated.

The administration time for an NDIS client is an estimate based on our previous experience of the time it takes to complete indirect services for NDIS clients (usually extra record keeping and time to plan for the session). However, Snapdragon Speech will only charge for the time taken to complete the above services. If it takes more or less time, the speech pathologist will discuss this with the client and bill accordingly.

Some assessments may take longer than one session to administer. If additional sessions are required, this will be discussed with you individually.

An assessment report is invoiced separately following the assessment at the indirect services rate. The cost of the report varies on the assessment completed, as speech pathology assessments vary in their complexity and level of analysis required.

Assessment/ Therapy Appointments (Private Paying Clients)	Assessment and therapy sessions for Private Paying clients are typically billed at 60-65 minutes + travel (if applicable) This includes 45-50 minutes of direct services (client may decide if they would like their direct appointment time to be 45 minutes or 50 minutes): • The time in the session • Discussion and feedback to parent, or if a school session, with the teacher. <i>Note: A 50 minute appointment may suit clients who need additional time to settle into the appointment or require additional breaks throughout; or for families that require additional time to debrief information.</i> And 15 minutes of indirect services: • Planning • Note-keeping. • Administration • Assessment scoring (for assessment sessions) • Brief phone calls and emails to keep you updated. The administration time for a private paying client is an estimate based on our previous experience of the time it takes to complete indirect services for our private paying clients clients. However, Snapdragon Speech will only charge for the time taken to complete the above servies. Development Of Therapy Plan In Relation To Allied Health Assistant Appointments	When commencing with an allied health assistant, the speech pathologist will create a therapy plan that outlines the client's goals, and activities on how to target these goals. This will typically be billed at 60 minutes (speech pathology rate). If additional time is needed, this will be discussed with you. The therapy plan will remain in place: • For 10 sessions, before a review of the therapy plan will be completed or; • The client has achieved the goals set out on the therapy plan or; • As advised by the speech pathologist or allied health assistant or; • At the request of the parent/guardian.	<u>NDIS Clients</u> \$193.99/hour	<u>Private Paying Clients</u> \$200/hour
Therapy With An Allied Health Assistant (NDIS Clients)	Therapy appointments with an allied health assistant for NDIS clients are typically billed at 60 minutes (allied health assistant rate) + travel (if applicable), and an additional 10 minutes (speech pathology rate). This includes 45 minutes of direct services with the allied health assistant: • The time in the session • Discussion and feedback to parent, or if a school session, with the teacher. And 15 minutes of indirect services from the allied health assistant: • Session planning • Note-keeping • Administration • Brief phone calls and emails to keep you updated. And 10 minutes of indirect services from the speech pathologist: • Checking over progress notes • Measuring any progress against goals • Discussion with the allied health assistant • Making small adjustments to the therapy plan, as needed. (Speech pathologist time will be billed on a monthly basis). And 15 minutes of indirect services from the allied health assistant: • Session planning • Note-keeping • Administration • Brief phone calls and emails to keep you updated. And 5 minutes of indirect services from the speech pathologist: • Checking over progress notes • Measuring any progress against goals • Discussion with the allied health assistant • Making small adjustments to the therapy plan, as needed. (Speech pathologist time will be billed on a monthly basis).
