Wedding Floral Contract

This agreement is entered into on _____ (date) by and between *Bride* and Lovenlily Floral (hereafter referred to as Florist)

Terms of Contract:

- Bride (or someone she has assigned) assumes all responsibility for the condition of the wedding order and other goods after delivery or pick up. It is hereby addressed by both parties that upon pickup or delivery of wedding flowers/products, Bride acknowledges that the florist has fulfilled all obligations of the contract.
- Bride agrees to pay ½ the wedding total to hold the wedding date. .Bride acknowledges this deposit is NONREFUNDABLE and will be forfeited in the event of the wedding is canceled or bride no longer requires the service of Florist. The deposit will be applied to the balance of the Bride's wedding package.
- Bride agrees to apprise the florist of all changes to the wedding order by 30 days prior to the event. We cannot reduce order once this date is passed. Additional purchase after this date will be invoiced separately and must be paid at time of order.
- Bride agrees to make the final payment 30 days before the wedding date. If payment in full is not received by said date this wedding contract will be terminated and the non-refundable deposit will be forfeited.
- Acceptable forms of payment are cash, check, or credit card. Credit cards will have a 3% service charge. Checks are to be made payable to LOVENLILY FLORAL

Substitutions:

- Bride agrees to communicate any color and/or flower variety preferences. Bride agrees to provide printed photographs with name,date, location and notes to help communicate preferences. (pinterest and email are acceptable) Florist will advise Bride on seasonality or specific flower varieties, however substitutions may need to be made based on availability issues, cost, Brides budget or other unforeseen or uncontrollable circumstances. By signing below Bride authorizes floral substitutions within the weddings specific color palette. Necessary substitutions will be at the designers discretion.
- If Bride chooses to not use a container Florist provides/has in stock, Bride must provide her own container. All containers provided by Bride to Florist must be approved by Florist based on size, shape and money spent to fill the container.

Consultations and Appointments

-If Bride feels another follow up appointment is necessary after the first consultation, Bride agrees to and understands that any follow-up aots will be made after the 30 day final payment is made.

Cancellations

-Cancellations will not receive a refund on any monies paid. Bride agrees that by signing this contract no monies given to Florist shall be refunded. Please let us know if there are extenuating circumstances and we will do our best to work with you.
