Obtain Federal Tax ID (EIN)	\$45
The primary purpose of an EIN is to allow the IRS to identify your company just as your social security number identifies you. Obtaining an EIN is required before you can open a business bank account or hire employees on behalf of your company. We can obtain an EIN from the IRS once your business has been formed.	
Initial Statement of Information	\$50
The State of California requires all corporations formed in the state to file a Statement of Information and pay any necessary filing fees within 90 days after the filing of the original articles of incorporation. We will prepare and file this document for you.	
Filing 501 (c) (IRS & California) for Non- profit organizations & Churches	Gross Receipt less than \$50,000\$225 + \$275 Applicable IRS & State fees. Total
Note: Churches (including integrated auxiliaries and conventions or associations of churches) that meet the requirements of section 501(c)(3) of the Internal Revenue Code are automatically considered tax exempt and are not required to apply for and obtain recognition of exempt status from the IRS.
