These simulators (AATD's) are approved by the FAA for Part-61 and Part-141 training. They can be configured for Cessna 172, Piper Seminole PA44 (Garmin 530 & 430), Piper Cub, Cirrus SR20 (Avidyne GLASS/Garmin430), and Cessna 172 G1000.

Private, Instrument, Commercial, Multi, Flight Review, IPC \$105/hour

CFI, CFII, MEI and ATP

Outside Instruction \$135/hour

PSA Flight Membership:

- To train at PSA or to be a renter at PSA you must be a member of PSA Flight Academy.
- Every new member (Renter or Student) will pay a one-time initiation fee of \$75 dollars.
- Membership fee of \$135 is paid every 3 months to keep PSA Flight Member status active for training and rentals. No monthly payments.
- **For the safety of the member and passengers, if a member has not flown at least 3 hours for 30 or more days at PSA (flying at another flight school or flying club does not count) then he/she is required to fly with a PSA flight instructor for MINIMUM of 1 hour (which should include at least 3 Takeoffs & Landings and emergency procedures) before renting the aircraft or flying solo.**
- Fuel surcharges may apply. Please check with Dispatch for fuel surcharge fees.

Required Insurance:

- All renters are required to carry renter's insurance prior to rental of the aircraft
- Liability: \$250,000 each occurrence, \$25,000 max each passenger
- Medical Expense: \$3,000/passenger including crew
- Physical Damage: \$20,000 (required)
