INSURANCE / PROFICIENCY REQUIREMENTS

1. **Aircraft Renter's Minimum Insurance Requirements:**
 - a. All students/renters are required to carry aircraft renters' insurance prior to rental.
 - b. Bodily Injury and Property Damage: \$250,000 / \$25,000
 - c. Medical Limit: \$5,000
 - d. Physical Damage: \$10,000
2. For the safety of our students/renters and their passengers, if the pilot has not flown at least 3 hours (dual or solo) for 30 days or more at PSA (flying at another flight school or flying club does not count) then the pilot is required to fly with a PSA Flight Instructor for minimum of 1 hour, which will include at least 3 takeoffs and landings and emergency procedures before renting the aircraft for solo flying or flying any passengers.

ADMINISTRATIVE FEE

Administrative fees help us cover administrative costs which help our students/renters with:

1. Online scheduling (aircraft & instructors) system access.
2. Off set additional Unleaded Fuel (No Lead Emission) cost and fees.
3. NO Fuel Surcharge fees.
4. Full Service is provided by FBO for fueling the aircraft (No Self Service).

Administrative fees are \$135 for three (3) months and one time account setup fee of \$75. There are no refunds on administrative and setup fees.

***Block rate discount is offered on Cessna 150 and Tecnam P2006T with minimum purchase of 20 hours.**
