Our next event is our state convention being held in Burlington MA, please make every effort to attend. In addition to other activities, there will be an election for four positions of the Executive Committee. As background three years ago the Executive Board and Committees had several long-term vacancies challenging the chapter in its pursuit of its goals. In addition, membership enrollment was reduced with retirements. Last convention two elected positions had no candidates, and a subsequent retirement created another vacancy.


I am pleased to point out that as I write this article our membership rolls and standing have increased and Massachusetts continues to be in the top ten in the country. Each of our previously vacant board positions and committee chairs are now filled. Regional positions such as RVP 010-013 Joseph Torcia and RVP 025-027 Jack Tompkins are appointments requiring confirmation by election in their respective areas. Michael Raymond RVP 014-017 announced he will not seek re-election creating an opportunity. Sylvain Labelle has announced his candidacy for Michael's position. Interim appointments of Secretary Treasurer and Editor now have candidates seeking election. Additionally, our bylaws provide for floor nominations at conventions which may increase the number of candidates seeking election. Some positions already have more than one candidate requiring a vote by the members to make a selection. Please read their announcements. Members are getting involved, sharing an active voice, participating at events, and strengthening our state chapter. Please keep it going and plan to attend the convention.

Lastly, you may recall I shared that at the last convention I stood in front of the whole country and had a brief dialog with Deputy Postmaster General Douglas Tulino. I shared feedback regarding the Supervisor Workload Credit program (SWCS). When Tulino summarily dismissed my question as a NAPS concern, I reminded him UPMA represents all EAS, and the problem is directly related to Postmasters and Managers as the Supervisors are their direct report and necessary to run their facilities. I have continued this conversation at every opportunity. I was pleased to read that there has been some movement within the program scheduled

to become effective in April 2023. The description of the changes are detailed in a letter viewable in our Facebook group. The changes may assist offices to regain a supervisor or an additional supervisor.

In summary, are we there yet? Absolutely not, but we are not sitting still, and we are moving forward.

# Legislative Summit Recap

Happy Spring to you all. We have just returned from a successful 2023 Legislative Summit in Washington DC. We had a great turnout of 20 members and a few spouses. We had actual face to face meetings with Senator Edward Markey and Congressman James McGovern (MA 2nd congressional District), as well as meetings with aides from Senator Warren's office and 5 other Representatives' offices. Luckily, most of the legislation that UPMA is lobbying for is also supported by most of the Massachusetts Representatives. However, Title 39 Reform, H.R. 595 the Postal Employee Appeal Rights Amendment Act of 2023, is the newest bill UPMA is looking for additional support on, as none of our Representatives have co-sponsored it as of this writing. Hopefully our visits will change that. This bill would extend the right of appeal to the Merit Systems Protection Board to any officer or supervisory, professional, technical, clerical, administrative or managerial employee of the Postal Service covered by the Executive and Administrative Schedule.

#### From the 2023 UPMA Legislative Issues Brief:

"UPMA supports forthcoming legislation that clarifies the representation of Postal Supervisors, Postmasters and Managers and the Postal Service's recognition of management associations.

UPMA supports efforts to strengthen the consultation process for non-collective bargaining-unit employees."

I want to thank those that joined us to support legislative efforts on behalf of UPMA, and I encourage those that didn't to join us next year. However, if you want to get involved, there's no need to wait! We will be having the MA UPMA State Convention June 23-25, the UPMA National Convention August 25-September 1, and the Atlantic Conference in the fall. Your MA Executive Board voted on the 2023 Fiscal Policy and made it incredibly easy and affordable to join us. Most expenses for each event are covered by the MA State Chapter.

# 2023 MA UPMA State Convention

It is time to mark your calendar and register for the MA UPMA State Convention to be held at The Boston Burlington Marriott in Burlington MA beginning at 11:00 AM on Friday, June 23 through Sunday morning, June 25, 2023. Early registration is May 23, 2023. First Timer registration is also May 23.

The MA Executive Board voted in the 2023 Fiscal Policy that MA UPMA members may request reimbursement for the expenses below to attend the state convention. The only requirements are that the member meets the registration deadlines, assists, and participates in the activities, and submits a provided voucher with all required receipts within 30 days to the Sec/Treasurer.

- Early registration for all members will be set at \$49 if postmarked by the date indicated on the registration form.
- Full registration after the early registration date will be \$99, with no reimbursement.
- Partial registration will be set by meal selections as indicated on the event registration form.
- There will be a \$20 daily business session fee without meals.
- Hotel room at the convention rate as indicated on the event registration form.
- Full non-member registration will be set at \$150 or partial registration will be set by meal selections as indicated on the registration form.

There will be one 50/50 drawing at the state convention designated for PAC.

CASH prizes will be given away throughout the convention. You can win more than once during the convention, but only once at each event. The catch: YOU MUST BE PRESENT TO WIN AND MUST HAVE YOUR BADGE. \$2,000 will be allotted for door prize drawings at the state convention for MA members only, excluding the six Executive Committee positions and any National Officers in attendance.

Look for the registration form in this issue of The BayStater, on the website www.maunitedpma.org and on Facebook. It has all the hotel information that you need. Send it in now before you set this magazine aside and miss the deadline. Look for the tentative agenda too so you can see what is being scheduled for you.

We will be holding state elections for the positions of President, **Executive Vice** President, Retiree President and Retiree Vice President for two-year terms each. Elections will also take place for the positions of Secretary/ Treasurer & Editor for one vear terms due to the appointment



of interim officers at the 2022 state convention. On a national level, we will be voting for the National Secretary/Treasurer and a National VP – East.

We will also be voting on the national proposed changes to the Articles of Incorporation, national bylaws and potentially proposed state bylaw changes.

For many years the MA chapter held an auction at the state convention. It was the biggest fundraiser to benefit the MA Scholarship Program. We will be doing that again this year, but we need your help. Please be sure to bring a new item to the convention for the auction. Also, please encourage other members who cannot attend the convention to donate an item for the auction and volunteer to bring it with you.

There is so much that your MA UPMA State Convention has to offer, and I have only touched on some. Make the commitment and put June 23-25 on your calendar and register early. Let me assure you that if you come to the convention, you will not be disappointed. If you came to conventions in the past, bring a friend this year. Listen, learn, vote, participate, and have fun. Meet up with old friends and meet new friends. Come and make the most of this opportunity to network and be together with people sharing similar experiences as you.

# National & State Articles, Bylaws and Officer Elections

#### STATE PROPOSALS AND ELECTIONS:

Both active and retired members have until April 24, 2023 to submit any proposed bylaw changes. If anyone needs help with this, please let me know. These will be distributed prior to the start of the state convention and will be presented and voted on during the convention.

In accordance with the MA UPMA bylaws, Executive Committee positions are to be filled by election at the State Convention by a majority of the vote cast. Normally, positions to be elected in odd years (2023) state conventions are President, Executive Vice President. Executive Committee positions to be elected in even years (2024) are Secretary/Treasurer and Editor.

Therefore, MA will be voting for the President and Executive Vice President for two year terms. Also, as outlined in the last issue of The Baystater, no candidates came forward to run for the positions of

Secretary/Treasurer and Editor in their election year of 2022, which were also for two years, so two interim officers were appointed to temporarily serve in these positions until such time as a MA member expressed interest in either position or an election was held in 2023 for a 1 year term,



whichever came first. Therefore, we will be voting for both of these officer positions for a 1 year term at the state convention.

The retirees will also hold elections for Retiree President and Retiree Vice President at their meeting. The Retiree President and Retiree Vice President shall be elected at odd numbered annual conventions to serve a term of 2 years, limited to 4 terms of office. The term of office for all newly elected officers shall commence on the first day of the month following that state convention.

#### NATIONAL PROPOSALS AND ELECTIONS:

This year there is 1 proposal to change the National Articles of Incorporation (AOI) and 5 proposals to change the National Bylaws. They were printed in the March issue of The Leader and are available for review on the national website at www.unitedpma.org. Please take some time to review this important information as they may affect you, the members, and they will be voted on at the MA state convention this year.

MA will be voting for a National Secretary/Treasurer and a National VP – East. There is more than one candidate for these positions, so please read up.

In accordance with the MA bylaws, voting will be by written ballot at the state convention with the outcome being converted to percentages and the results will be cast during the 2023 national convention in Denver CO.

If you are delivering mail and are a Postmaster grades EAS-18 thru EAS-22 and all levels of Managers, Customer Services- you are to be paid 035 time for the time you spend delivering that mail. If that makes you work 12 hours to do your Postmaster job and delivering the mail, don't ignore that benefit, document the event in RADAR under EAS carry mail survey and make sure your additional hours are paid to you. UPMA fought hard and long for this to be afforded to us, if we do not do the right thing, it will expire on April 7, 2023. If you have the time documented and are a timecard office and no one puts your time in, please reach out to your Manager or a member on the Executive Board of UPMA to get your fair pay. We all need to understand the pay package which expires this year. If you are a level 20 Postmaster without an authorized Supervisor in SWCs your occupational code should be 2301-6220. You are classified as Special Exempt, not to deliver mail in other offices but to be paid additional hours if your operational needs are more than 8.5 hours in a service day or any hours on your NS Day in your own office. Most of us are 6-7-day operations. There are only 8 positions in the state that are currently classified as such. Education of leadership is essential.

I feel that my data analysis and willingness to help and assist any member will be a huge asset to Massachusetts UPMA. I am not afraid to advocate on behalf of others' rights as I continue to do this for myself every day.

We can facilitate a meeting with the manager in question and start a process to help resolve a tense situation. The role of the Chapter Member Representative is not limited to just representation for PDI's and potential adverse action. We are here to help you and guide you through tough times as well, and happy to do so. My contact information is on the back page

of this publication. Please feel free to reach out any time of the day for assistance. Don't ever feel like you must go it alone.

Since things are quiet, I wanted to touch on another topic. I have been a member of UPMA (formerly NAPUS) going on twenty years now. Over the past several years, I have noticed a steep decline in attendance at local meetings and convention attendance. 
These days Ruth spends her time with her daughter Danielle


# What happens at the Summit?

# **Working Together**



As the appointed Area Regional Vice President for 025 -027, I am happy to have this opportunity to introduce myself to you. My name is Jack Tompkins and my home office is Mashpee. I reside in East Falmouth with my wife Jill. Yes, we are Jack and Jill. Our adult daughter and son both happen to be living in the suburbs of Philadelphia.

My career as a Postmaster started

when John Fitzpatrick hired me to run the office in Vineyard Haven. While on the island, my staff developed great team work not only within our office, but also with amazing Postmasters on the Cape: Bob O'Connor, Damen Nix, Bob Boccuzzi, Mark Donlan, Mike and Laurel Lynch, Janine Cox, Donna McKenzie, Ryan DiEoreo, Tom Driscoll and Ken Fleming. We would not have been able to deliver the onslaught of packages during the pandemic if we did not have the management expertise, carriers and trucks shared by these Postmasters.

I believe UPMA can provide such support to all Postmasters. We need to regain trust of each other and develop relationships among our fellow Postmasters to make each office successful. We all face the same challenges: lack of equipment, personnel and time. The answer is not for Postmasters to be delivering the mail. The answer is for us to perform our duties as Postmasters at the highest level and manage our employees to help them be better at their jobs and train them to meet our customers' expectations. We can do this if we work together to find solutions.

I returned recently from the UPMA Legislative Summit in Washington DC. There were 350 Postmasters from across the country. During Postmaster General DeJoy's welcome speech, he shared that 40 more S&DC units will be opening this year across the country. This trend of removing carriers from our home offices will affect all of us within the next five years in my opinion. We were then trained to lobby Congress on several issues and were divided into smaller groups. We asked for support of three different bills, including Title 39 Reform, which would extend the right of appeal to the Merit Systems Protection Board to any officer of supervisory, professional, technical, clerical, administrative or managerial employee of the Postal Service covered by the Executive and Administrative Schedule. In short, this will bring equal protection to all managers. My day consisted of meetings with Congressman McGovern, Congressman Keating's staff and Senator Markey and his staff. They all have a deep appreciation for the hard work of Postmasters and our importance to their local communities. One Congressman informed our group of a bill being circulated that has bi-partisan support to bring back the mail delivery standards of 2012. Time will tell.

I hope we will have the opportunity to meet in person at our next Chapter meeting. I appreciate that Damon Nix accepted the appointment of Treasurer for our Regional Area. 
