A New Year

We are now 7 full months into the new fiscal year with no NPA goals. National leadership is discussing NPA with headquarters. While they do, I would not expect anything to leak. Part of the delay was waiting for the NALC and the USPS to reach an agreement. Since they are now the largest union, UPMA must wait until that agreement is reached. I see 3 possible scenarios – 1) flat % across the board for everyone, 2) continue to use last year's NPA goals, or 3) no raises at all. But that is just gazing at the crystal ball. No one knows what's going to happen.

By the time this comes out, Priority Mail Express will now be guaranteed by 6pm instead of 10:30, 12 or 3. I am sure this rubs a lot of us the wrong way. Our premier product is now no longer as premier as it was before. On top of that, the price didn't go down. I think we are moving closer to other delivery companies. Most companies that offer next day service usually just guarantee the day not the time. A lot of our issues with getting PME delivered on time are out of our control. We don't have our own planes so we are at the mercy of the airlines. Maybe this will help us with our on-time performance. I don't know, but to me it feels like another one of the "death by a thousand cuts".

We have many positions available for you to get involved with Massachusetts UPMA. State elected positions up for election this year are President, Vice President, Sec/Treasurer, Editor, Retiree President and Retiree Vice President. Several Regional Vice President positions are open as well as the appointed positions of PAC/Legislative Chair and Parliamentarian. We also always need help with chapter member representation. If you've been interested in learning more and getting involved, now is the time. If you are concerned about not knowing how to do a certain position, believe me when I tell you that all the people that are exiting the positions will be more than happy to guide and train you. You won't be going in blind. There will be plenty of support to help you be successful. Your success is our success as a state chapter.

We are having our state convention this year! Last year we decided not to have it due to Covid concerns. By not having a convention, Massachusetts was not able to participate and vote at the national convention. This year we will have our state convention at the Sturbridge Host Hotel which is a beautiful spot out west. It is large enough that we can socially distance and safely conduct a 2-day convention July 29th and 30th. We will be getting straight down to UPMA business for 2 days. There are over 2 dozen national bylaw changes to consider as well as some state bylaw changes that all need to be discussed and voted on. There will not be no guest speakers or a district manager panel this year. After many wonderful years on the Cape, the Executive Board decided to move the convention to a more central location to make it easier for more of our members (YOU) to attend. I am really looking forward to this year's convention and seeing everyone. COVID robbed us all of so much last year. It will be nice to get some normalcy back. Please come to state convention!



2021 MA UPMA STATE CONVENTION



It is time to mark your calendar and register for the MA UPMA State Convention to be held at The Sturbridge Host Hotel in Sturbridge beginning at 8:00 AM on Thursday July 29 through Friday afternoon on July 30, 2021.

Early registration for all members is set at \$49 if postmarked by June 18, 2021. These registrations will be refunded at the conclusion of the State Convention to members that fully participated in convention activities. Full registration after June 18 will be \$99, with no reimbursement. Free registration is provided for all EAS MA members who are attending the state convention as a First Timer and register by June 18.

Partial registration for members is a daily fee of \$20 for business and/or training sessions only. Members who plan to attend partially and attend specific meals should pay the individual meal costs outlined on the registration form, instead of the \$20. If postmarked by June 18, 2021, this registration fee will also be refunded at the conclusion of the State Convention to members that participated in convention activities.

Full non-member and guest registration is set at \$150 to cover the costs of the meals. Partial registration will be set by meal selections.

Don't miss the chance to save some money! Plan ahead and take advantage of the Early Bird Specials. Look for the registration form in this issue of The Baystater, on the website www. maunitedpma.org and on Facebook. Send it in now before you set this magazine aside and forget. We will be holding state elections for the positions of President, Executive Vice President, Retiree President and Retiree Vice President for two-year terms each. Elections will also take place for the positions of Secretary/Treasurer & Editor for one year terms due to the cancellation of the 2020 state convention which resulted in a one year extension of their 2018 term.

The E-Board is also looking for individuals who are interested in serving as the state Legislative/ PAC Chair and the Parliamentarian.

On a national level, we will be voting for the National President of UPMA and for 1 vacancy to serve as East Area National Vice President. As of now, there is only 1 candidate for each of these positions. See their biographies in this issue of The Baystater which is a reprint from the January/ February 2021 issue of The Leader.

CASH prizes will be given away throughout the two day convention, including at each of the training sessions. You can win more than once during the convention, but only once at each event. The catch: YOU MUST BE PRESENT TO WIN AND MUST HAVE YOUR BADGE.

VOTEVOTEVOTEELECTIONS FOR STATE AND NATIONAL OFFICERSAVAILABLE STATE POSITIONS

PROPOSED AOI AND BYLAW CHANGES: This year there are 3 proposals to change the National Articles of Incorporation (AOI) and 25 proposals to change the national bylaws. They were printed in the March issue of The Leader and are available for review on the national website at <u>www.unitedpma.org</u>. Please take some time to review this important information because they may affect you, the members, and they will be voted on at the MA state convention. Any proposals to change the MA state bylaws must be submitted at least 60 days prior to the start of the MA convention. These too will be voted on during the convention.

STATE ELECTIONS: In accordance with the MA UPMA bylaws, Executive Committee positions are to be filled by election at the State Convention by a majority of the vote cast. MA positions to be elected at the 2021 MA state convention are **President**, **Executive Vice President**, **Secretary/Treasurer**, **Editor**, **Retiree President** and **Retiree Executive Vice President**.

<u>ACTIVE MEMBER ELECTIONS</u>: The President and the Executive Vice President shall be elected at the annual convention in odd numbered years to serve a term of two years. These officers shall be limited to two consecutive terms of office. The Secretary/Treasurer and the Editor shall be elected at the annual convention in even numbered years to serve a term of two years. The **Secretary-Treasurer and Editor** may be elected to serve unlimited terms of office. Officers will be sworn in at the state convention and the term of office for all newly elected officers shall commence on the first day of the month following the state convention. (Note: The Sec/Treasurer and the Editor will be elected for a term of 1 year due to the cancellation of the 2020 state convention which resulted in a one year extension of their previous term.

Any member of this chapter, in good standing, may nominate a candidate from the floor for any elective office. The election of officers shall take place during the state convention of this chapter and it shall require a majority of the vote cast to be elected. In the event of a tie vote, the Executive Board shall decide the election; each member will cast one vote. All elections must be held by written ballot, with the exception of an unopposed candidate who may be elected by the casting of one vote by either the President or the Secretary/Treasurer.

With the exception of the positions of President and Executive Vice President, which shall be limited to active EAS members who are members in good standing of the organization, Retired Postmasters, retired EAS employees and Postmaster Reliefs shall be permitted to hold office in this chapter provided they are present at the meeting where the vote will be taken and that no other active EAS member seeks the office. Any active member who is an officer of this chapter, who during their term shall resign or be removed for any cause whatsoever, from the position that qualified them for active membership, shall immediately become ineligible to hold office and their office shall be declared vacant.

The duties and responsibilities of these positions are outlined in the MA bylaws as follows:

President: The President shall preside at all meetings of the chapter, shall call special meetings when requested to do so as provided in Article IV. They shall also preside at the meetings of the Executive Board and appoint all committees for the proper handling of the business of this chapter and in general perform such duties as may pertain to the office. The President must be an active member. The president shall receive such compensation for their services as provided for in the fiscal policy.

Executive Vice President: The Executive Vice President shall serve in the absence or disability of the President and work with the President as needed. This position will be a separately elected position and must be an active member. Should the office of the President be vacated, the Executive Vice President will serve the remaining term. The remaining term of the vacant position of the Executive Vice President shall be assigned by the Executive Committee. The Executive Vice President will have additional duties assigned by the Executive Committee. The Executive Vice President shall receive such compensation for their services as provided for in the fiscal policy.

Secretary/Treasurer: The Secretary/Treasurer shall combine the office of Secretary and Treasurer, and may perform all duties commonly incident to both offices. The Secretary/Treasurer shall be bonded as provided in Article XIV hereof. The Secretary/Treasurer shall keep all records, record the proceedings of all conventions and meetings of the Executive Committee and Board, deposit, withdraw and have custody of the funds of the chapter and shall be responsible to keep an accurate and complete account of the receipts, vouchers and membership. In the event of a vacancy in the position of Secretary/Treasurer shall receive such compensation for their services as provided for in the fiscal policy. (The January 2021 fiscal policy authorizes a monthly stipend of \$350 for the Secretary/Treasurer for the performance of the duties.)

Editor: It shall be the Editor's duty to publish the official newspaper of the Massachusetts Chapter of UPMA. The Editor shall receive such compensation for their services as provided for in the fiscal policy. (The January 2021 fiscal policy authorizes a stipend of \$250 to the Editor as compensation for every publication in support of the Chapter.)

<u>RETIREE MEMBER ELECTIONS</u>: The **Retiree President and Retiree Executive Vice President** shall be elected at the annual chapter convention to serve a term of 2 years. The term of office shall commence on November 1 and will end on October 31. The officers shall be limited to 4 terms of office.

The election of officers shall be conducted at the annual Chapter Convention. Candidates to be elected to respective offices must be present when their name is placed in nomination. Members in good standing who are registered for the annual chapter convention and present when ballots are cast are eligible to vote in chapter officer elections. Elections shall be by majority vote cast by ballot. In the event that no majority is reached, the two candidates with the most votes will compete in a run-off election. Where no contests exist, election may be by acclamation. Additional or other nominations may be made from the floor, if seconded and approved, and shall be included with the list of candidates presented by the nominating committee.

Retiree President: The President shall preside at all meetings of the Chapter, shall call special meetings when requested to do so as provided in Article IV. They shall also preside at the meetings of the Executive Board and appoint all committees for the proper handling of the business of this Chapter and in general perform such duties as may pertain to the office. The President shall receive such compensation for their services as the Executive Board may provide.

Vice President: The Vice President shall serve in the absence or disability of the President and work with the President as needed. This position may be a separately elected position. Should the office of the President be vacated, the Vice President will serve the remaining term. This would not exclude that person from seeking a full elected term as President. The remaining term of the vacant position of the Vice President shall be filled by the Executive Board. In addition, the Vice President may serve as the Membership Chair for the Chapter. It shall be their duty to promote membership for the organization, and insure that the Chapter always has a strong membership.

VACANT MA COMMITTEE CHAIR POSITIONS: In accordance with the MA bylaws, the Executive Committee will be responsible for the assignment of committee chairs. Currently MA has two vacant committee chair positions. If you are interested in becoming involved and holding one of these positions, please contact State President Dave Branga. You may also contact the incumbents for more information regarding the assignments, Robin Driscoll and Donna Legro, respectively.

Legislative/PAC Chair: Duties include keeping abreast of legislation and sharing this information with the Executive Board and its members; participating in the national office legislative telecoms as scheduled (usually in the evening); coordinating activities and meetings for the annual legislative summit; raising PAC awareness and encouraging PAC donations, and fundraising for PAC by raffles or other ideas.

Parliamentarian: Duties include ensuring MA Chapter business, including all Executive Board meetings, conventions, etc, are conducted in accordance with the MA bylaws, the MA Fiscal Policy and the National bylaws, as well as ensuring all proposed bylaw amendments are properly submitted and presented to the membership in accordance with the MA bylaws and Roberts Rules of Order.

NATIONAL ELECTIONS: MA will be voting for a **National President for UPMA**. There is currently one candidate for the position, Edmund Carley, Postmaster of Lincoln IL. We will also be voting for **one National VP East.** Again, there is only one candidate for the position, Jeff Lightner, Postmaster in Eldred PA. Please read their biographies in this issue of The Baystater.

VOTING & RESULTS: In accordance with the MA bylaws, voting is required to be by written ballot at the state convention with the outcome being converted to percentages and the results will be cast during the 2021 national convention in Sandusky OH.

Signature FCU Scholarship Program For college or trade school-bound members
