HUMANS ACTIONS CAUSE 68% OF DATA BREACHES

The Cyber Security Staff Awareness Recognition Scheme, co-organised by HKIRC and ISACA, was launched in 2024 to recognise organisations for their commitment to strengthening cyber security and enhancing staff awareness. We are delighted to announce that applications are now open for the upcoming round of the Scheme for 2025.

New Elements for This Scheme

New Assessment Criterion – Conduct "Cyber Security Risk Assessment"

This criterion has been introduced to encourage organisations to further enhance their cyber security defenses.

New Recognition Tier – "Diamond"

This tier is designed to honor organisations that have achieved the highest level of recognition for two consecutive years, acknowledging their sustained commitment to cyber security excellence.

New Categorisation of Organisations

Organisations will now be categorised into "Large Enterprise" and "SME" groups based on employee count, ensuring a tailored evaluation approach for each category.

Cyber Security Staff Awareness Recognition Scheme

Assessment Criteria:

Cyber Security Training

Provide online or physical cyber security training to at least 50% of staff within the past 12 months.

Staff Engagement in Phishing Drills

Ensure that all staff have participated in a phishing drill at least once in the past 12 months, utilising either self-developed exercises or ethical drill programs offered by third-party organisations.

Establishing a Robust Cyber Security Policy Framework

Develop and maintain a comprehensive cyber security policy accessible to all staff, covering key areas such as remote work policies, AI usage guideline, and incident response procedures.

Establishing Clear Reporting Pathways for Cyber Security Issues

Establish effective reporting channels that enable staff to promptly report cyber security concerns. This includes the creation of a dedicated channel specifically for the reporting of suspicious or malicious emails.

Promoting Cyber Security Awareness Through Active Information Sharing

Enhance the dissemination of cyber security information among staff by actively participating in cyber security information-sharing platforms and providing regular updates and announcements.

Annual Cyber Security Risk Assessment Requirement

Conduct cyber security risk assessment at least once within the past 12 months.
