## AIR GUN CLUB FACILITIES WAIVER, RELEASE AND INDEMNITY

• I, (the undersigned) desires to use the air gun range facilities located on Pima County Assessor Tax Parcel No. 304-29-902B (the "Facilities"). I acknowledge and understand that there are inherent risks, hazards and dangers to which I will be exposed because of the nature of air guns and rifles and shooting sports. I have consulted with my physician to the extent I deem appropriate to determine that I am in proper physical condition to participate in such activity. Neither acceptance of this Waiver, Release and Indemnity nor any other action on the part of any of the Robson Parties (as defined below) shall constitute in any form or manner a medical judgment and does not suggest that any of the Robson Parties is qualified to make medical judgments. The Robson Parties strongly recommend that each individual consult with a physician before engaging in air gun shooting activities, as well as undergo training/instruction for the handling and use of an air gun. I understand, acknowledge and agree that none of the Robson Parties will provide any accident or health insurance for me.

• I hereby expressly acknowledge the risks, dangers and hazards associated with my participation in the air gun shooting activities, my use of the facilities and of air guns and rifles (whether as a participant in or an observer of the activities), whether herein described or not, and I freely accept and assume any and all such risks, dangers and hazards and the possibility of personal injury, death, property damage, and any other loss resulting therefrom. I understand and agree that my use of the air gun facilities and any equipment provided shall be undertaken at my sole risk, and neither the Quail Creek Air Gun Club (the "Club"), Robson Ranch Quail Creek, LLC, Arlington Property Management Company, Quail Creek Country Clun Property Owners Association, Robson Communities, Inc., any affiliate of any of them or any of their respective officers, directors, owners, members, managers, partners, employees, agents or representatives (collectively the "Robson Parties") shall be responsible or liable for any damage, harm or injuries of any kind, nature or description to me or my property or my guests or be subject to any liability, obligation, action, claim, demand or suit whatsoever for injury or damages, including without limitation those resulting from the active or passive negligence on the part of any of the Robson Parties, except to the extent directly caused by the sole active negligence or willful misconduct of such Robson Party.

• I, on my behalf and on behalf of my insurers, executors, administrators, heirs, successors and assigns, hereby waive, release and forever discharge and further agree to indemnify, hold harmless and defend Robson Entities for, from and against any and all actions, claims, demands, liabilities and suits relating to my use of the facilities, conveniences or equipment, including without limitation the air gun range or otherwise relating to or arising out of my participation in shooting sports including without limitation those resulting from the active or passive negligence of any of the Robson Parties, except that the undersigned does not release and shall not be obligated to indemnify or hold harmless a Robson Party from such Robson Party's sole active negligence or willful misconduct.

• I am comfortable with my ability to operate any equipment at the Facility that I choose to use, including air guns and air rifles that I brought to the Facilities. I acknowledge and understand that neither the members of the Quail Creek Air Gun Club nor any instructor who may be teaching at the Facilities, including without limitation any safety training class, is an employee, agent or representative of the Robson Parties and neither the content of the class nor the qualifications of members in the Air Gun Club nor any such instructor have been approved, investigated or endorsed by any of the Robson Parties.

• The undersigned agrees to abide by and comply with all stated rules, regulations and customary terms and conditions of the Club and Robson Parties and all laws, rules, regulations, ordinances of any government, agency, municipality or political subdivision.

• The undersigned warrants and represents that no promise or representation of any kind has been expressed or implied by the parties released herein or by anyone acting for them, except as is expressly stated herein. The undersigned represents that he/she is over the age of 18 and is legally competent to execute this document. This document shall be construed according to its fair meaning and neither for nor against any party hereto irrespective of which party caused the same to be drafted.

• I acknowledge and understand that neither the Club, its directors nor any of their respective affiliates is an employee, agent or in any way affiliated with the Robson Parties. Neither the activities nor qualifications of the Quail Creek Air Gun Club have been verified or approved by any of the Robson Parties. The Club is not sponsored or endorsed by the Robson Parties in any way; rather the Club has merely obtained a revocable permissive use license with Robson Ranch Quail Creek, LLC to use the property.

• I certify that I am lawfully authorized to possess equipment and engage in activities consistent with the purpose and facilities of the Quail Creek Air Gun Club. If admitted, I will uphold the principles of good sportsmanship and abide by all Club rules and by-laws.

• BY EXECUTING THIS WAIVER, RELEASE AND INDEMNITY, I ACKNOWLEDGE THAT I HAVE READ, UNDERSTOOD AND AGREED TO ALL OF THE TERMS OF THIS WAIVER, RELEASE AND INDEMNITY.
