## Council Work Session

## Copperton Law Enforcement Services

Mayor Clayton asked if anyone had anything to add to the letter.

Nobody had anything to add.

**Mayor Clayton** asked if the Council had any individuals it could recommend to sit on the law enforcement steering committee.

Council Member Severson suggested Randy Cox.

Council Member Stitzer suggested Apollo Pazell and Amanda Doyle.

**Mayor Clayton** suggested Joel Brienholt, Ben Villanueva, and Brian Vinton. He plans on talking to the Lion's Club on Thursday to see if anyone is interested. He asked the Council members to send him the email addresses of the nominees.

**Mayor Clayton** asked Council Member Olsen what he needs in preparation for the next day's meeting.

**Council Member Olsen** stated the agenda includes a motion for "approval of funding for new Chief of UPD reorganization." He guessed it was probably to approve a salary for Chief Jason Mazuran. Sheriff Rivera plans to take over his responsibilities and he will shift exclusively to reorganization duties. This could be a good thing as Mazuran knows Unified Police Department (UPD) well and can do a good job, but conversely, he will be more likely to create a similar version of the UPD that already exists. He was not sure Chief Mazuran would keep Copperton's best interests at heart.

Council Member Stitzer asked if the Board had considered any other options for

CEO.

**Council Member Olsen** stated the only other candidates seriously discussed were Lieutenant Justin Hoyal, whom he would prefer, and Chief Wayne Dial. He predicted most of the Board would most likely go for Chief Mazuran, as he was Sheriff Rivera's top choice.

Mayor Clayton asked why Sheriff Rivera was still taking part in the discussion.

**Council Member Olsen** stated the Board asked her to remain as an advisor throughout the transition.

Council Member Stitzer asked if there were any other items on the agenda.
