AN ORDINANCE APPOINTING THE GREATER SALT LAKE MUNICIPAL SERVICES DISTRICT AS MUNICIPAL ENGINEER FOR THE TOWN OF COPPERTON

WHEREAS, the Town of Copperton ("Copperton") is a town class pursuant to Utah Code § 10-2-301(2)(f); and

WHEREAS, Copperton is a member of the Greater Salt Lake Municipal Services District ("MSD"), which provides administrative services to Copperton; and

WHEREAS, since its incorporation in 2017, the MSD has contracted with Salt Lake County to provide engineering services to Copperton and the MSD's other municipal members; and

WHEREAS, the MSD has established an engineering department that includes many of the engineers and staff from Salt Lake County's engineering department that will provide engineering services directly to the MSD's municipal members, including Copperton; and

WHEREAS, the MSD's engineering department will become effective on January 1, 2024; and

WHEREAS, under Section 10-3-917 of the Utah Code, towns may by ordinance establish the office of the municipal engineer; and

WHEREAS, Section 17B-2a-1104(1)(b)(iv) of the Utah Code permits the MSD to provide engineering services to its member entities; and

WHEREAS, the Copperton Council desires to appoint the MSD to serve as Copperton's municipal engineer.

NOW, THEREFORE, BE IT ORDAINED BY THE COPPERTON TOWN COUNCIL AS FOLLOWS:

- 1. Effective January 1, 2025, pursuant to Utah Code § 10-3-917 and Utah Code § 17B-2a-1104(1)(b)(iv), the Greater Salt Lake Municipal Services District is hereby appointed as the municipal engineer for the Town of Copperton to fulfill all applicable duties and responsibilities set forth in the Utah Code, Copperton's ordinances, and all other applicable laws and regulations.
- 2. The Mayor and Copperton staff are authorized to take such steps as are necessary to implement this ordinance.
