## **Amenity Information**

### **Pools**

Both pools are open May 1<sup>st</sup> until October 1<sup>st</sup>. Current hours are 9:00 am – 10:00 pm. Your Amenity Access Card is required to enter.

South Pool and Amenity Center is located at 221 Country Lakes Blvd.

North Pool and Amenity Center is located at 9101 John Paine Road.

### **Dog Park**

The Dog Park is located at the North Amenity Center at 9101 John Paine Road.

Park hours are 6:00 am – 9:00 pm.

Your Amenity Access Card is required to enter.

### **Owners Association at Country Lakes (HOA)**

Is responsible for management, maintenance, repair and control of common areas. Page 6, Article III of CCR's.

Annual dues are \$725, billed semi-annually.

\$362.50 is due January 1 and July 1.

**Recycling and Trash Pickup**

Monday – Argyle residents (three-digit address)

Tuesday – Denton residents (four-digit address)

Containers may be placed at the curb four feet apart after 6:00 pm the evening before scheduled pickup and must be placed out of sight by 8:00 am the day following scheduled pickup.



**Community Garage Sale**

Community garage sales are scheduled in April and October. The exact Saturday date will be posted one month in advance.

**Fishing**

Fishing is not allowed in lake 1,2,3,4 or 5.

**Catch and Release** fishing only, is allowed in all other lakes.

No swimming, wading or boating is allowed in any lake or water way.

**Annual Meeting**

The Country Lakes annual meeting is held in the fourth quarter of the year. A formal notice will be mailed.

## **Be a GOOD Neighbor**

We can all work together to be better neighbors to each other by following some simple guidelines including mowing your lawn and trimming your shrubs regularly, using weed control, storing trash cans out of public view, keeping barking dogs quiet, having dogs and cats on a leash when outside, picking up after your pet, being considerate when hosting parties by noise/music control, not revving up your motorcycle or vehicle on your street...are just a few ways you can show consideration to your neighbors.

Be helpful to your neighbors by watching out for them and reporting any suspicious activity in the area, checking on elderly neighbors if you have not seen them, reporting any street lights that are out to the appropriate city, watching out for the children that live here and obeying the speed limits. **Please do not hesitate to call the police.** Keep Country Lakes as safe as it can be.

# COUNTRY LAKES POOL RULES

## **ALLOWED IN THE POOL**

- PERSONS UNDER 16 YEARS OLD MUST BE SUPERVISED BY AN ADULT OVER 18 YEARS OLD.
- SWIMWEAR ONLY CAN BE WORN IN POOL.
- BABIES WITH SWIM DIAPERS SUPERVISED BY AN ADULT AT ALL TIMES.
- NON-GLASS BOTTLES ONLY ALLOWED AT POOL SIDE.
- FOOD IN CABANA AREA ONLY.
- HOUSEHOLD ONLY – UP TO 4 GUESTS.
- TRASH DISPOSED OF IN TRASH CONTAINERS.

## **NOT ALLOWED IN THE POOL**

NO FOOD EXCEPT UNDER CABANA AREA ONLY.

NO ELECTRIC, GAS, CHARCOAL, FIRE BURNING APPLIANCE OR APPARATUS ALLOWED IN THE CABANA OR POOL AREA . NO COOKING OR GRILLING ALLOWED IN THE CABANA OR POOL AREA.

NO ALCOHOL OR GLASS CONTAINERS ANYWHERE.

NO SMOKING IN POOL/CABANA/FENCED IN AREA.

NO STREET CLOTHES OR JEANS IN THE POOL.

NO BABIES WITHOUT SWIM DIAPERS. NO CHANGING DIAPERS EXCEPT IN RESTROOM.

NO DIVING, JUMPING OFF THE LEDGE, RUNNING, ROUGH HOUSING, ABUSIVE LANGUAGE, LOUD MUSIC OR NOISE.

NO BIKES, SCOOTERS, SKATEBOARDS, MOTORIZED VEHICLES, LARGE TOYS, GAMES, EQUIPMENT, NETS, BASKETBALL HOOPS, RAFTS, OTHER LARGE FLOATATION DEVICES IN POOL/CABANA/FENCED IN AREA.

NO PERSONS WITH OPEN SORES OR INFECTIOUS DISEASES.

NO ANIMALS IN THE POOL/CABANA/FENCED IN AREA.

NO NON-MEMBERS. VIOLATORS WILL BE PROSECUTED.

NO VANDALIZING. VIOLATORS WILL BE PROSECUTED.

THE HOMEOWNERS ASSOCIATION ASSUMES NO RESPONSIBILITY FOR ANY PERSONAL INJURY, LOSS, THEFT OR DAMAGE TO PERSONAL PROPERTY OR EFFECTS LEFT IN THE POOL AREA.

# DOG PARK RULES

- **PARK HOURS: 6:00AM – 9:00PM**
- USE AT YOUR OWN RISK. Owners/handlers are legally and financially responsible for the actions and behavior of their dogs at all times.
- Maximum 2 dogs per owner/handler.
- Be courteous of others when using the facility.
- Clean up and dispose of feces left by your dog. Bags and receptacles are provided.
- Owners/handlers must be within the Dog Park with leash readily available at all times.
- Dogs may NEVER be left unattended.
- Dogs must be on leash when entering and exiting the Dog Park.
- Dogs showing aggression towards other dogs or people must be removed immediately.
- Dog collar must display current rabies vaccination tag.
- Children under 16 must be accompanied by a parent or legal guardian.
- Please report any inoperable or broken equipment to management: 940-489-4243.
- Any damages to common areas will result in amenity access suspension and/or fines.

## **PROHIBITED**

- Dog food, treats, human food, alcohol, smoking, and glass containers.
- Bones, rawhides, and squeaky toys or stuffed toys. (Balls and frisbees are acceptable).
- Excessive barking. Dogs barking continuously or uncontrollably must be removed from Dog Park immediately.
- Professional dog trainers and/or groomers are not permitted to conduct their business.
- Dogs in heat, sick dogs or those with fleas, ticks, worms, or other parasites.
- Puppies under 4 months of age.
- Digging. Owners must stop dogs from digging and immediately fill holes.
- Children running or chasing dogs.
