I realize that the Hardcore House to which I am applying for residency has been established in compliance with the conditions of § 2036 of the Federal Anti-Drug Abuse Act of 1988, P.L. 100-690, as amended, which provides that any federal money loaned to start the house requires the house residents to (A) prohibit all residents from using any alcohol or illegal drugs, (B) expel any resident who violates such prohibition, (C) equally share household expenses including the monthly lease payment, among all residents, and (D) utilize democratic decision making within the group including inclusion in and expulsion from the group.

In accepting these terms, the applicant excludes himself or herself from the normal due process afforded by local landlord-tenant laws.

1. Attend (2) worship gatherings at a Bible believing church and (2) 12 step meetings per week, all house meetings.
2. Abstain from any chemicals/ alcohol.

RESPONSIBILITY: Each house holds weekly business meetings. As a member you will participate in these meetings, have full voting rights and may even be elected by the other members to hold an office. House Officers are elected every six months. Your house will help you learn the procedure of their Hardcore House meetings. We encourage you to learn the duties of each House Officer. The love that Jesus has for you will move you closer to each in the house and supporting each other will be a privilege that you participate in.

\_\_\_\_\_ I understand that if I am placed on a contract for any reason (i.e. rent, curfew, behavior) and am found by a majority vote to be in violation of that contract, I understand that I will be immediately expelled from the house.

\_\_\_\_\_ I understand that as a house member, I further agree to the following terms upon my departure from this residence, under any circumstances; personal items will be removed from within and around this residence within 72 hours. If personal items are not removed from this residence within 30 days of departure date, on day 31 any remaining items will be donated to a charitable organization.

PROBATION GUIDELINES:

During your first thirty (30) days of residency we want a chance to get to know you and want you to get a chance to become familiar and comfortable with the way a Christian community under Hardcore house guidelines.

- Curfew: Sunday Thursday: \_\_\_\_\_pm, Friday – Saturday \_\_\_\_\_
- Meetings: (2) Bible based church, (3) 12step with a signed meeting sheet, all house meetings
- NO overnight Guests and NO overnight stays outside of the house
- female (no significant other) guest can visit in common areas (no bedrooms) when at least 1 other member is home up until 2 hour before curfew.
- NO phone calls on the house phone before 7am or after 10pm
- Weekly house meeting is MANDATORY. Excused absences are: work or House functions; with 24-hour notices of planned absence. Missing house meetings without excuse is cause to be expelled from the house.
- You MUST find a job within 2 weeks of moving into the house.
- You MUST find a sponsor within 2 weeks of moving into the house
- Chapter meetings are MANDATORY for your first 3 months, you must attend 3 meetings; A \$50 fine will incur if you miss a Chapter meeting.

RENT: E.E.S. (Equal Expenses Shared) E.E.S. is determined by your Oxford House, members pay one week in advance.

Upon arrival to the house, a NON-REFUNDABLE deposit plus one week EES is due. You must be at a zero balance in order to be voted off probation. Staying current is non-negotiable.

EES is due by 7 pm on Saturday, every week. **MONEY ORDERS ONLY.** Money Orders are to be made payable to your house and "For Deposit Only" is to be written on the back and placed in your houses lockbox. **NO CASH ACCEPTED!**

Upon completion of probationary contract, members will be reevaluated in a House Meeting and voted in as permanent members of your Hardcore House. ANY MEMBER WHO DOES NOT FULLFILL THE 30 DAY CONTRACT, WILL EITHER BE PUT ON EXTENDED PROBATION OR THEIR MEMBERSHIP IN THE HOUSE WILL BE VOTED ON IN A HOUSE MEETING.

Hardcore House Guidelines: Each house is autonomous and operates in accordance with the Hardcore House Model. Each house must adhere to the Hardcore House Charter, Traditions, and House Manual. No member is ever voted out of a Hardcore House without cause: 1) Relapse 2) Not attending meetings 3) Non-payment of EES 4) Disruptive Behavior

Recovery comes first and principles come before personalities. Behavior modification should be addressed in the following order: 1) Warning 2) Contract 3) Expulsion

#### MEMBERS:

1. Two overnights per week. No more than 2 nights without house approval.
2. 10:00 P.M. curfew
3. MANDATORY minimum of (2) church gatherings and (2) 12-Step meetings per week, all house meetings.
4. New Member restriction placed on every member behind on EES.

#### GENERAL PRINCIPLES:

- No active users or drinkers allowed on the property
- No sexual immorality as sex is exclusively for husband and wife.
- No narcotics are allowed in the house at any time. If you are on medications, you must inform your house and keep it out of sight AND IN A LOCKED BOX.
- Laundry hours are set by your house, be respectful of your housemates.
- Be respectful of your housemates during the week, keep the noise down after \_\_\_\_\_ pm

If you feel these expectations are too strict then possibly Hardcore House is not for you. Expectations are to help maintain order and peace. Following Jesus is not complex. Love Him, love each other. And remember...THERE ARE NO BOSSES in Hardcore Houses. We have one Lord: Jesus.

You are just as important as anyone in the house (*Jesus has a plan for you*). You have just as much of a say in house decisions as anyone else. The best friend we can be to each other is to hold each other accountable and not allow our old selves to be lord. The guidelines are only good if they are followed as a community of believers that follow Jesus as Lord in humble obedience to Him alone.
