Article III Section 1	Date of annual meeting of the members moved from last Thursday of March to third Saturday of March	Member vote?	<p>There is mention in the December 1983 minutes that this would be put to a member vote alongside the ballots for the directors. However, no vote is recorded or mentioned in the minutes that this actually happened.</p> <p>The amendment was to be returned to the secretary by March 16, 1984.</p> <p>This is, however, the month, week, and day that the annual meeting of the members has been happening for as long as anyone can currently remember.</p>
1987-03-21	Article XV Section 8	To recover part of attorney fees against persons failing to follow the CC&Rs or delinquent in their assessments	Member vote	March 21, 1987 minutes of annual meeting of the members. Vote count: 564-96, approved
2019-12-12	Article IV Section 2	Created staggered terms for directors	Board of Directors only No member vote	<p>In litigation for not complying with Charter and rightfully amended and recorded Bylaw Article XVI Section 1 of 1969.</p> <p>On March 2, 2022, the Board declared that this Bylaw change was invalid and null and void since proper procedure was not followed to enact this change.</p>

Board of Directors only No member vote	<p>In litigation for not complying with Charter and rightfully amended and recorded Bylaw Article XVI Section 1 of 1969.</p> <p>This amendment can stand or fall on its own as a member vote may have been taken in 1984. Although December 1983 BOD minutes mention that there would be a member vote on this, no vote is mentioned or recorded on the matter at the annual meeting in March, 1984.</p>
