Terms Of Contract

- 1) This mare is booked specifically by name, tattoo and neither the booking nor this contract shall be sold, assigned, leased or in any other manner transferred without the prior written consent of Triple ZZZ Stable.
- 2) Triple ZZZ Stable its agents, employees, and the owners of the Stallion shall not be liable for injury, death, or disability suffered by the mare from any cause whatsoever, while in its custody, and the Owner of the mare assents to such condition and waives each and every claim for damages resulting from any such injury, death, or disability.
- 3) Service fees are due and payable if the mare has a live foal or changes ownership, whichever comes first. In the event the mare is sold, the service fee, if unpaid, shall immediately become due and payable to Triple ZZZ Stable with no refund due.
- 4) If the mare fails to produce a live foal (A live foal is defined as one that can stand up and nurse), a veterinarian certificate must be presented to Triple ZZZ Stable no later than thirty (30) days after foaling to claim a refund.
- 5) All accounts, veterinary, breeding services and board bill, are due and payable monthly to Triple ZZZ Stable by the Owner of the mare upon receipt of the monthly statement. A 2% monthly service charge will be added to any balance over 15 days. All accounts must be settled before the mare is removed from the premises.
- 6) In the event the stallion shall die, be removed from the stable, or in any way become unfit for services before servicing the mare, or if the mare should die or otherwise become unfit to be bred supported by a veterinarian certificate, this contract is and shall be null and void. Mare owner shall notify Triple ZZZ Stable immediately if the mare dies or otherwise becomes unfit to be bred.
- 7) Triple ZZZ Stable reserves the right to reject any mare not in good condition or one that is vicious or unmanageable or not standard and registered by the United States Trotting Association. No blind mares accepted. Any mare entering the premises shall present a current negative Coggins test, EHV vaccination no older than 6 months, Strangles vaccination, and a current statement on vaccination history. Triple ZZZ stables reserves the right to test any barren mare at the owner's expense, and she will not be bred until she is cultured and found free of any genital tract infection. The undersigned owner hereby agrees to all the terms and conditions specified above and represents that all information regarding the mare herein is true and accurate.
- 8) The opening and closing dates of the Triple ZZZ Stable breeding season are determined solely by the Stable.
- 9) There will be a non refundable collection fee of \$150.00 due at contract submission.
- 10) There shall be no modification, waiver, amendment, cancellation, or abandonment of any of these terms or of the agreement unless the same is in writing and signed by the parties.
