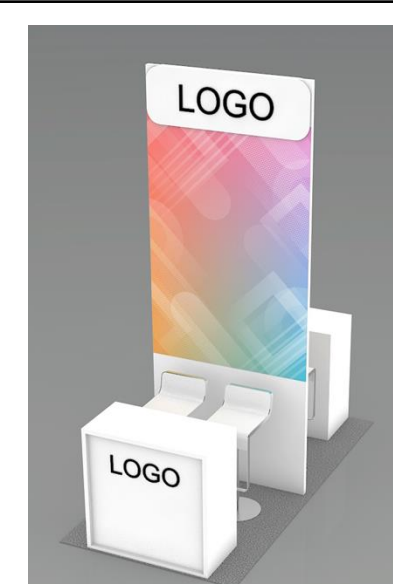

INNOVATIVE INDIA PAVILION Layout @ BIO International Convention Botson

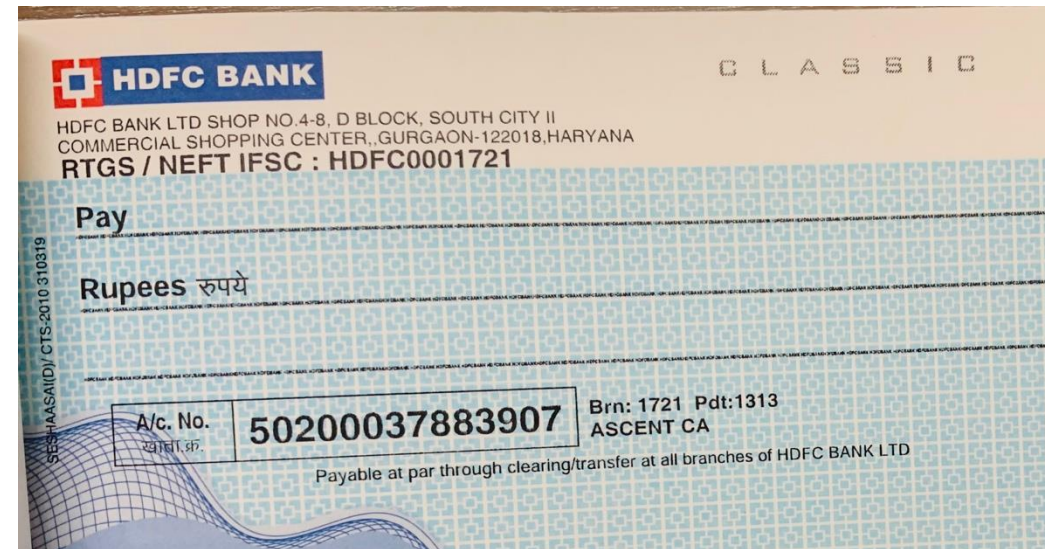
