

## Pup Shield Warranty for Reasonable Veterinarian Expenses for Accidents for Dogs

This warranty covers reasonable veterinarian expenses for accidents up to:

\$1500 or \$2500 depending on the plan you chose.

This warranty is valid from the date of purchase and as long as your monthly payments are current and paid in full.

To be eligible for reimbursement under this warranty, the following conditions must be met:

- The accident must occur during the warranty period.
- The dog must be properly secured and not involved in any illegal activity at the time of the accident.
- The veterinarian expenses must be reasonable and directly related to the accident.
- To make a claim under this warranty, you must provide the following.
  - A copy of the original sales receipt from the purchase of the puppy.
  - A detailed report from a licensed veterinarian outlining the injuries sustained by your dog and the treatments provided.

Proof of payment for the veterinarian expenses.

Once we receive your claim, we will review it to determine if it meets the conditions for reimbursement under this warranty. If your claim is approved, a check will be mailed to you within 14 business days for the reasonable veterinarian expenses up to the coverage limits. ## **Coverage Includes:**

- Lacerations: Cuts or wounds requiring medical attention.
- Broken Bones: Fractures in bones that need diagnosis and treatment.
- Bite Wounds: Injuries caused by animal bites, requiring medical care.
- Toxin Ingestion: Poisonous substance ingestion requiring urgent veterinary intervention.
- Snake Bite: Venomous snake bite necessitating immediate medical assistance.
- Bee Stings: Injuries caused by bee stings, potentially requiring treatment.
- Eye Injuries: Damage or trauma to the eye, needing prompt veterinary attention.

This warranty does not cover any expenses related to illnesses or diseases, routine check-ups or preventative care, pre-existing conditions, or any expenses exceeding the coverage limits of the chosen plan.

By purchasing this warranty, you agree to abide by its terms and conditions. This warranty is non-transferable and cannot be combined with any other warranties or guarantees.

Foot McGuffin LLC DBA Pup Shield ("Seller") warrants to the original purchaser ("Buyer") that the puppy with microchip number \_\_\_\_\_\_(the "Product") will be covered for certain vet bills as a result of an injury as detailed below.

If, during the Warranty Period, the Buyer's dog suffers an accident that requires veterinary care and that injury is directly caused by an accident, Seller will reimburse the Buyer for reasonable and customary veterinary expenses incurred by the Buyer up to the maximum amount stated in the chosen plan. To be eligible for reimbursement, Buyer must provide Seller with proof of purchase, proof of the accident and the resulting veterinary care, and any other documentation that Seller may reasonably require. Buyer must also follow any instructions provided by Seller regarding the submission of claims for reimbursement.

THIS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SELLER'S LIABILITY UNDER THIS WARRANTY SHALL BE LIMITED TO THE COST OF THE REASONABLE AND CUSTOMARY VETERINARY EXPENSES INCURRED BY THE BUYER UP TO THE MAXIMUM AMOUNT STATED IN THE CHOSEN PLAN, AND IN NO EVENT SHALL SELLER BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES.
