# **By-Laws**

### The Mission Statement

The Brant Rock Village Association would like to make Brant Rock a viable community. We wish to educate and inform our community on current events. We wish to preserve our community. We hope to make our community socially stronger.

Officers: shall consist of a President, Vice-president, Treasurer and Secretary who will remain in office for 2 years.

Executive Board: shall consist of the Officers and Executive members voted in from the previous election. On election years prior to the annual meeting in July the board will nominate the officers and executive board. These meetings will be held in June. A quorum will consist of majority vote.

Standing Committees: shall be appointed as necessary by the Executive Board.

### Article I - Name

The Name of this organization shall be the Brant Rock Village Association, Inc.

# Article II - Purpose

The purpose of this organization shall be to improve the quality and safety of our neighborhood for residents and businesses. To make Brant Rock a pleasurable place to come to.

## Article III - Membership

Membership in this organization shall be open to all who live and work in the Fieldston, Ocean Bluff, Brant Rock and Green Harbor areas and to any other person or Corporation the Executive Board's majority vote deems acceptable.

### **Article IV – Elections**

The Executive Board shall appoint (in June) the nominees for the next 2 year term the Officers and the Executive Board. In July (bi-annually) the members will vote in the Officers and the Executive Board. Vacancies will be filled at the next quarterly meeting of the Executive Board and voted on at the next quarterly meeting.

# Article V – Meetings

The quarterly meetings for the Association will be held on the forth Wednesday of July, October, January, and April (keeping in mind the annual meeting is in July).

### Article V – Meetings (continued)

The Executive Board quarterly meetings for the Association will be held on the forth Wednesday of June, September, December and March (keeping in mind the nomination meeting is in June).

In the event of a holiday the Executive Board will reschedule that meeting at the prior meeting (not to exceed two weeks from original date).

### Article VI – Finances


Membership fees shall be set by majority vote at annual membership meeting in July. Expenses shall be met by the solicitation of members.

The role of the Treasurer shall be to maintain records, fees and dues.


The role of the Secretary shall be to maintain written records of meetings and decisions of the board and regular meetings.




# Marshfield and Its Planning Areas
