- 3.2. Greg Burroughs from Peterson McGregor in Traverse City does the Authorities through most of Michigan and all of northern Michigan, he has worked with ESIP for 15 years and would be willing to come to a meeting to talk about insurance coverage.
- 3.3. Motion presented by Joe, seconded by Dave, to have the Authority Chairperson sign the quote with Peterson McGregor to keep it active. All approved, motion carried.

New Business:

1. Leases - The Board will review and send Kim any concerns by Friday night so we can give feedback to the lawyer if changes are required.

2. Mesick Rescue Contract

- 2.1. The goal of having the Authority contract with Mesick Rescue is to ensure they can continue providing services to the community until the Authority is operational.
- 2.2. Discussion around the contract proposal included: revise to reimburse for actual expenses/cash paid out while keeping Mesick Rescue's bank balance at a minimum of \$35,000 so there is some operating income for float until the Authority reimburses Mesick Rescue. Mesick Rescue will provide an invoice for the prior month along with monthly bank statements. A clause should be added that all unexpended Township and Authority funds will be returned to the Authority.

- 2.3. Concern raised regarding the statement in the proposed contract that "This contract supersedes all EMS contracts with the above-mentioned Townships". While the Authority has been formed by the 4 townships, the Township Boards need to approve the termination of their individual contracts with Mesick Rescue.
- 2.4. General consensus that the Townships need to make a resolution to cancel their current contract with Mesick Rescue contingent upon the Authority executing a contract with Mesick. This will ensure no lapse in coverage by the Townships. We will ask the Townships to approve transferring their rights to receive the unexpended Township funds in their current contract to the Authority. This is to streamline the process so Mesick Rescue won't have to figure out the proration by Township, pay each Township, then have the Townships pay the Authority.
- 2.5. The Authority will need the Township millage revenue and the cash accrued with Mesick Rescue to cover the 2022-2023 budget year. This is a partial budget year as most of the townships paid a portion of the current Fire/EMS providers directly during the 2021 tax collection period. In addition, the taxes collected during the 2021 tax collection period are to fund the Townships' 2022-2023 fiscal year. The Authority's fiscal year is 7/1-6/30.
- 2.6. A formal motion was not made, but the general consensus was that Mesick Rescue and certain members of the Board would be able to finalize the contract between the Authority and Mesick Rescue without involving the lawyers. Kim will draft the Township Termination Notice based the discussion but did advise that both the Authority/Mesick Rescue Contract and the Termination Notice should be reviewed by a lawyer given they are intertwined, yet separate contracts.
- 3. **Ambulance Billing Class** Motion was made by Joe, seconded by Dave, to send Erica Szegda to the class on 11/9 at the Treetops Resort in Gaylord to represent the NWEA we will pay for the class (\$80) and buy lunch for Erica and Jim Peterson (Jim will drive). All approved, motion carried.

Public Comment

Next Meeting: Motion presented by Joe, seconded by Kim, to meet on Tuesday, November 15, 2022 at 6pm at Mesick Rescue Squad. All approved, motion carried.
