#### **Approve Prior Meeting Minutes:**

P. Benz read the minutes from last month. Motion made by P. Benz, seconded by D. Williams, to approve the minutes from 01-12-23. All approved, motion carried.

**Public Comment:** S. Brewer commented that E. Szegda had opened accounts at Forest Area Federal Credit Union and was currently the only signer. Gave information of what is needed to add others.

**Treasurer Report:** E. Szegda gave report: there is \$269,418.17 in checking and \$278.31 in savings at Honor Bank and \$182,442.40 in ambulance savings, \$15,659.75 in fire savings, and \$7.38 in checking at FAFCU. \$5,284.94 at Honor Bank is part of the fire savings. No bills were paid last month. E. Szegda stated that there is \$1,617 coming back from the lawyer due to an overpayment from reading the billing information incorrectly. Motion made by S. Needs to be updated once insurance is finalized; then presented to the Township boards in their January/February meetings.

#### **New Business**

Village of Buckley lease agreements: Buckley says Authority needs to sign first. T. Williams to contact Takis for clarification. Motion by D. Williams, seconded by S. Neufer to allow T. Williams to go ahead and sign the lease agreement. All in favor – motion carried.

Mesick Rescue Invoices: Bill presented from Mesick Rescue for 01/23 expenses - \$57,285.32 minus \$19,425.48 income = balance \$37,859.84. Discussion regarding breakdowns. Motion by P. Benz, 2<sup>nd</sup> by D. Williams to pay Mesick Rescue bill. All in favor, motion carried.

Articles of Incorporation: State of MI rep says we just need to fill out a form and submit it to change our FY end date. E. Szegda received form today and will fill out and send. T. Williams stated that he heard Art. Of Inc., minutes, and state paperwork need to go to IRS. Art of Inc. need wording revised to allow alternates – tabled.

Received a proposal from A. Sherburne for EMS training – discussion held - tabled for now.

Question posed regarding the I Am Responding bill for Springville Fire. Discussion held. It was recommended that Springville Twp pay the least expensive option as it is due in March. NWEA did not want to take on that bill at this time, as there are probably multiple subscriptions that will be able to be combined.

E. Szegda reported that Springville Township requested that we provide input on the pump truck situation. The truck that was presented by CSI at their meeting was discussed. \$90,000 – 7 year pump warranty. Another truck was presented by E. Szegda that she found through Spencer Fire Trucks for \$20,000. C. Wolfe also spoke about a few options for trucks that he had found. P. Benz reported that The Village of Buckley would probably sell or lease their spare truck (as an immediate band-aid) to cover the Fire Department immediately. S. Neufer stated that truck broke on last two runs. Discussion about mutual aid – Colfax, Harrietta, and Buckley are backups. T. Williams stated that the input from NWEA would be to reach out to Buckley and pursue the lease option. P. Benz questioned the funds available from Springville Twp. W. Floury reported that they have approx. \$178,000 in fire savings. S. Brewer also

P. Benz introduced the desire to establish a Director position. Discussion held. S. Neufer stated the Bylaws eliminated the position he thought. T. Williams wasn't sure. T. Williams stated the job must be posted because we are using public funds. P. Benz asked for permission to create the job description and post the position so we can begin to receive resumes. Motion by D. Williams, seconded by S. Neufer to give P. Benz the authority to carry out this task. All in favor – motion carried.

**Next Meeting:** Motion presented by P. Benz, seconded by S. Neufer, to meet on Thursday March 9<sup>th</sup> at 6pm at Mesick Rescue Squad. All approved, motion carried.
