## *Festival Overview*

The **Environmental Art & Music Festival** will be held April 22-23 in downtown Union, S.C. The Festival celebrates the beauty of nature and all things outdoors with a focus on sustaining the natural resources of our region through conservation and preservation. A twilight market will begin Friday, April 22 @ 5pm with live music concluding at 8 pm. Saturday, April 23 the market will have the hours of 10 am - 6 pm. Enjoy a variety of exhibits, the Piedmont Physic Garden as well as our historic Main Street corridor which includes the Union Arts Council, the Union County Museum, retail shops and other small businesses.

## *Festival Policies*

1) While the festival does have music, entertainment, food and nonprofit organizations, the focus and highlight of the festival are the artisans.

2) Your food Truck must be disconnected from your vehicle before the road closes on Friday and Saturday and your vehicle must be out of your spot.

3) Setup time for Friday, April 22, 2022, will be at 3:00PM. Setup for Saturday will be 8:00AM

4) Health Inspectors may be on site. Food license must be visible.

5) Each Food Truck must have his or her own trash bags and can.

6) Electricity is limited -please be specific about your needs

7) Vendors must obtain insurance coverage to cover property damage and personal injury arising as a result of the food truck or third-party action. Under no circumstances will the **ENVIRONMENTAL ARTS AND MUSIC Festival** organizer(s) and/or sponsor(s), the Piedmont Physic Garden or the City of Union be responsible for any damage to food truck or vendor's products and vendors agree to hold them harmless from any and all liability arising out of food truck's acts and/or omissions.

8) Food Truck must have a Sales Tax Number and Business License. YOUR LICENSE MUST BE ONSITE THE DAY OF THE EVENT FOR INSPECTION BY THE STATE. [WWW.SCTAX.ORG](http://WWW.SCTAX.ORG)

9) There is a \$10 Non-refundable Application Fee that is due with the application. If accepted as a Vendor, you will be invoiced for your Vendor Fee. The invoice for your Vendor Fee is due upon receipt in order to reserve your space at the festival. Deposits or portions of the Vendor Fee will not be accepted.

10) The Vendor Fee for your booth is \$75. We will invoice you after we notify you of the acceptance of your application to the festival.

11) Your business license fee for the operation of your FOOD TRUCK will be included with your invoice if your application is accepted. The Business License is \$10 for Union residents and \$20 for non-residents.

12) Electricity is limited. Please be specific on your electricity needs by emailing [winter@piedmontphysicgarden.org](mailto:winter@piedmontphysicgarden.org). Power is available at various locations and must be

prearranged. Electrical power requests will be considered on a first-come, first-serve basis. You must provide your own power cords. Electricity fee is \$25 and will be included with your invoice after we notify you of your acceptance to the festival.

13) This is a rain or shine event. No refunds will be given.

14) FOOD TRUCKS may remain in place on Friday night. However, it is recommended that all merchandise, products and items of worth be stored in a locked vehicle or trailer overnight. Union police will patrol the area and traffic will not be allowed in the festival zone at night. Under no circumstances does the **ENVIRONMENTAL ARTS AND MUSIC FESTIVAL** organizer(s) and/or sponsor(s), the Piedmont Physic Garden or the City of Union, warrant or guarantee the safety of the booth, its contents or individuals

15) Security for your merchandise, booth and property are your responsibility. Please be watchful and a good neighbor

16) Only registered FOOD TRUCK participants will be permitted to conduct business during the

## **ENVIRONMENTAL ARTS AND MUSIC Festival.**

Booth sharing is not permitted.

17) Keep a copy of your application for your own records.

18) Load-in and load-out procedures as well as parking will be sent to you prior to the Festival.

19) All FOOD TRUCKS must participate in both days of the Festival and must remain until the close of the Festival. No early departures are allowed.

20) Setup time for Friday, April 22, 2022 will be at 3:00PM. Setup for Saturday, April 23, 2022 will be 8:00AM
