I LOVE MY NEIGHBORHOOD

My husband and I bought our mid-century modern house in Long Point Woods 3 in 2000. We bought it from the original owner who had not lived in it full time for many years and there was a lot of deferred maintenance and updating to do. I didn't love the house immediately. As a matter of fact, in my opinion the house was ugly -- no landscaping, dark interior, cracked sliding glass door, plexiglass in the clerestory windows, etc. -- and it needed a LOT of TLC. Although I usually could see past the condition of a home and see the potential, it just wasn't working for me on this house. But my husband, Jeff Harris (a past SBCA president), was drawn to the open floor plan and we bought it despite my reservations. Since we moved in, I have grown to love our house and the neighborhood that surrounds it. Our area has seen many changes in the years we have lived here, particularly the removal of the railroad tracks and Old Katy Road, the widening of the Katy Freeway and the re-development of the entire Bunker Hill/Katy Freeway intersection, all of which has had some positive and some negative consequences. Nothing changes however the sense of community that I feel when I walk the neighborhood and see these lovely older homes and mature trees and visit with our neighbors. Since my retirement from banking seven+ years ago, I have become a rodeo volunteer and become more involved with the civic association. I am proud to serve on the Board and do what I can to keep our neighborhood safe and help keep us all connected and informed. We are fortunate to live in such a beautiful area with a good location and great neighbors. Even with our issues with drainage and traffic, I am happy to be here and can't think of anywhere else in Houston that I could enjoy more.

DEED RESTRICTIONS

It's important to know your neighborhood and read over your deed restrictions. These can be found, along with maps, on our website – https://springbranchcivic.com/.

The Spring Branch Civic Association encompasses nine separate platted residential subdivisions plus Spring Manor Town Houses. The subdivisions are Bunker Hill Forest (Sec. 1& 2), Century Oaks, Long Point Woods (Sec. 1, 2, & 3), Spring Branch Woods (Sec. 1, 2, & 3), and Spring Manor Town Houses. When each of these subdivisions was platted, deed restrictions were also established. Since these are separate neighborhoods each with its own deed restrictions, naturally there are some differences between them, while some common elements also exist.

One of those common elements is that of restricted to residential use. Each set of deed restrictions states that its respective subdivision shall be used for residential purposes only. While each set of deed restrictions may provide slightly different detail, clarity, or definition, the element of residential remains the same.

In future newletters, we'll introduce other common and differing elements of our deed restrictions.

ABATEMENT OF FLOOD DAMAGE by Richard Hall

In the past 10 years our neighborhoods have flooded increasingly into homes and businesses. Associations to abate flooding have been formed. Public meetings were held to discuss flooding issues. Lawsuits were filed. Candidate campaigns are based on flooding. Federal, State and Municipal Governments are processing flooding abatement. We have many political strategies and programs to abate flooding damage. A reasonable person might ask: WHAT COULD I PERSONALLY DO TO HELP ABATE FLOOD DAMAGE?

View the catch basins and gutters surrounding the home. These basins and gutters should be free of leaves, grass, branches, dirt, debris and trash. The large items wedge into the basins and storm sewer pipes. Smaller items pile up against the larger items, which blocks the efficient flow of water from your area. Even leaves and smaller items can block up the grate and opening of the catch basins. Leaves and grass on a fence can impede the efficient flow of water from our yards. Dirt placed on a yard for landscaping can flow into the gutters and clog up storm sewers and flood ditches.

Trash and debris from vehicles driving through the neighborhood and from homes in the neighborhood joins the leaves, grass, branches and dirt and flow into the gutter and to the catch basins. Then the runoff flows through pipes to ditches into the water ways and out to sea from our subdivisions. Keeping gutters and catch basins clean is something a reasonable person can do to help abate flooding damage.
