Crafter/Business/Retail Vendors: Please be specific on what you want to sell as are those products you will be able to sell. Once you're a vendor at the market and would like to add additional items, you can discuss with the onsite manage.

Service Vendors: You can only hand out and promote the information you requested in your application.

Non-Profit: First night is complimentary. If you would like to schedule additional night(s) you can discuss dates and fees with onsite management. You are only allowed to share the information you are accepted for, and please **do not** include any other organizations or services.

Food Vendors: If you prepare your food at home you will need a Cottage Food Operator permit - (http://publichealth.lacounty.gov/eh/business/home-based-cottage-food.htm. Health permits and insurance are required for all food vendors.

Wait until you are approved before applying necessary permits and insurance.

Set up starts at 3:00 with your booth ready for the public at 5:00 p.m. Your first night bring your completed signed application, and payment for the first night (check or cash). You will do all future scheduling with Amy. We provide the space and electricity. (see page 2 for details)

Table Only Space: Available for Bussiness' and Organizations

You are not allowed to hand out any food or beverage items without prior permission from management.

Important Payment Information: As a vendor, you are not obligated to participate each week. If you do not participate regulary there is no assurance that you will be in the same location or can return with the same product. Please let management know when you will not attend and will return.

NOTE: Bring a copy of your permits (Seller's permit and Health Dept. if applicable.) Permits must be displayed in your booth every week.

ATTENTION VENDORS: You must keep your booth open until closing time or management tells you otherwise. You will receive authorization from management when to bring your car into the park for loading.

2023 Covina Application Participant Definitions, Requirements, Rules, and Fees

Space set up (craft area): Pop-up canopy, 8'x8' or 10'x10' straight leg preferred; table(s) for display; table cover(s) to the ground, no table legs or boxes showing; 8 1/2 by 11 in. contact sign (name and phone number) placed where it can be seen by public. Lighting or electrical appliances must be clip-on cone lights with energy saving bulbs, no heaters or A/C units.

State Board of Equalizations: You must obtain a seller's permit if you: are engaged in business in California and Intend to sell or lease tangible personal property that would ordinarily be subject to sales tax if sold at retail; will make sales for a temporary period, normally lasting no longer than 30 days at one or more locations (e.g. fireworks booth, Christmas tree lots, garage sale). The requirement to obtain a Seller's Permit applies to: Individuals • Partnerships • Corporations • Organizations • Husband/Wife Co-ownership • LLP's • LLC's. Both wholesalers and retailers. **Provide a copy to the Market for their files**.

VENDORS MUST HAVE SELLER'S PERMITS (bring copy for CFM&FN files) HEALTH PERMITS MUST BE POSTED IN BOOTH.

Direct Sales Vendors do not need a Seller's Permit. All vendor fees are based on per Friday night participation.

Farmers & Plant Growers	Farmer's accepted by request only with certified permit. Space negotiated based on variety of product(s).
Fee: 7% of gross + \$2.00 CDA fee	Plant growers must have a Nursery permit - \$27.00. If selling house, potted plants a nursery license is necessary. If selling trees and/or big plants from a nursery a Agriculture permit is needed.
Prepared Food/ Restaurant* Fee: \$82.00**	Food prepared/served on site and sold and served open. In compliance with the Department of Environmental Services (Health Department) The first night of participation please bring your health permit and proof of Insurance.
