I appreciate you taking the time to assist here. Unusual.

I have a current situation in front of me that needs my attention prior to even attempting any type of resolution. Yesterday I received a complaint for discrimination from the NAACP. Both myself and La.Serena (the building) are named.

I have never met the Strongs. Never spoken with them other than a few e mails. My property manager says it's not them as he doesn't believe they are African American. Jill Ealy who sold the business to them says he is (AA) and she isn't but that he is not involved in the business. Sorry confusing.

I spoke with a representitive of NAACP and they wanted me to come in next week for an "interview." I live in Hawaii. The rep for NAACP refused to disclose any information re the complaint or where the complaint has been filed or by whom. Jill Ealy says she spoke with Mrs. Strong and says they indeed did file a descrimination complaint with NAACP. Obviously I will neither jump to a conclusion or act on anything until I sort this out.

You might imagine that if the Strongs did file this I will not forgive this act.

In any case nothing with the complaint is happening any time real soon. I am not running over for an interview without an attorney that I don't even yet have.

Perhaps I will have more information after the holidays. Mine will be less joyful than planed.

Hi Chief Dally,

This is Steve Yates landlord for CBG.

I agreed with the tenant to reach out to you to discuss their music permit application.

The current license expires this month and they want a new one for the following year. I have received 53 recorded complaints from my tenants of noise violations- nuisance regarding the bands playing there weekly.

I spoke with Capt. Ryan in, I think June regarding the complaints internal to the building. She asked that I handle it internally. I decided to cut the rent to the tenants in half for the remainder of the year as compensation for the disturbance. I still lost a tenant.

This IS an internal building matter. Bands on a weekly basis don't work in this local. It's in the lease. Should be simple, right?

Anyway I'm open to any thoughts you may have and completely understand a "not our problem" position by CPD. As it stands I will not take a position of CBG over the rights of other tenants, so I will not sign for approval of a new license that CBG violates every band night. (DBL levels in the apartments reach as high as 105, 90 is normal from them.

65 is the limit per regulation. (They admit to 85 + Dbl 3 ft. away from the apartment)

Anyway I'm open to any thoughts you may have re music in River City!
