



## **BAT Firearms Training, LLC & Private Range Club Membership**

WHEREAS, in consideration of the use of the shooting range and facilities operated by Thomas E. Gwinn, DBA BAT Firearms Training, LLC, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

I hereby apply for Private Club Membership with BAT Firearms Training, LLC. I pledge to abide by the rules below and to observe and obey all posted rules and warnings. I further agree to follow any oral instructions or directions by BAT Firearms Training representatives, or agents of BAT Firearms Training, LLC.

Membership is effective upon the date of this form. Fees for membership are as follows:

- 1 year membership is \$1,200 / year; members may bring guest(s) at \$15.00/hour with signed range waiver.
- Monthly membership is \$125/month; members may bring guest(s) at \$15.00/hour with signed range waiver.
- Membership will expire 1 year from the date of the agreement; monthly membership will expire 30 days from date of the agreement.
- **Range hours are 9 a.m. to 7:00 p.m.** (if natural light permits); during months of reduced lighting, time will be ½ hour before sunset.
- **IF** other parties are shooting on pistol lanes, **no** rifles will be fired.
- Membership may be revoked with no reimbursement for any unsafe act deemed by BAT Firearms Training representatives or agents.

The Undersigned hereby acknowledges and agrees to have voluntarily applied to use the shooting range and facilities operated by BAT Firearms Training, LLC. It is understood and acknowledged that the use of a shooting range in which others, as well as the Undersigned, are engaged in shooting activities involves inherent extreme hazards, dangers, and risks. The Undersigned represents that he/she is physically able, emotionally stable, and fully competent to participate in training and shooting activities and that he/she freely, knowingly, and voluntarily assumes the risks of participating in such activities, including the risks of property damage, bodily harm, and death.

The Undersigned affirms that he/she has and will refrain from being under the influence of alcoholic beverages or medications that might impair judgment prior to, and during, shooting sports activities. Further, the Undersigned affirms that he/she understands the possession and influence of unlawful drugs is expressly prohibited on the range property, and that any person(s) who, strictly by our observations, appears to be under the influence of alcohol or unlawful drugs or emotionally unstable, shall be denied access to any part of the shooting range facility.

The Undersigned affirms, under penalty of law and perjury, that he/she can legally possess or rent a firearm and that he/she has no criminal or mental background that restricts the Undersigned from such possession.

The Undersigned acknowledges that certain ammunition is restricted on this range and that he/she may not use armor piercing, steel core, incendiary, tracer, or reloaded ammunition outside of manufacturers' specifications. **If such is used, any damages resulting from such use may be billed directly to the Undersigned.**

The Undersigned takes full legal and financial responsibility for any damage or harm to himself/herself, and to his/her minor guests, if any, and for damages or harm to other individuals on the premises, rental equipment, or other range equipment that is a result of the actions of the Undersigned and/or his/her minor guests.
