Future Membership Information

You will be eligible for this program if one of the adults in the family unit is under age 30. To be considered a family unit, couples must be married (engaged couples may qualify if approved by the Club). There is no limit on the number of times you can take advantage of this offer as long as you meet the requirements. The ages will be based off your age at the start of the calendar year, January 1st.

At age 30, you will go into a new dues category which is \$1000 plus tax for the season. You may do this for 5 years until you reach the Age of 35. This program allows you to continue membership on a discounted dues structure and provides a path to stock ownership which is required by CCC bylaws when you reach the age of 35.
